Nearest main highways are I-880 and U.S. 101. Nearest communities are Fremont and Newark. Fishing is allowed year-round. Refuge waters include approximately 6 miles of shoreline plus one fishing pier. A fishing license is not required of anglers who use Dumbarton pier. Available species include striped bass, sculpin, shark, croaker, halibut, sturgeon and crabs.



**Guadalupe-Nipomo Dunes National Wildlife Refuge**, managed as part of Hopper Mountain NWR Complex, 1055 Guadalupe St. (Scenic Hwy. 1), Guadalupe, CA 93434; (805) 343-9151. Office hours, 9:00 am-3:00 pm. Nearest communities include the City of Guadalupe and Pismo Beach. Nearest highway is Hwy. 1. Surf fishing and access to the refuge is south along the shoreline halfa-mile south of the end of the boardwalk. For more information, go to http://www.dunescenter.org. Available species include surf perch and striped bass. The refuge has no facilities. Fishing season is year-round.

Fishing is permitted over refuge tidelands. Non-motorized boat launch and dock are at the Hookton Slough Unit. Public boat launch is at Fields Landing. Fishing season is year-round. Available species include shellfish, jacksmelt and shark.

Refuge is open during daylight hours. Nearest main highway is U.S. 97. Good access roads. Nearest community

is Chemult, OR. Public fishing is permitted along the Silver Lake Highway in the borrow ditch adjacent to the marsh. No boating is allowed.



Modoc National Wildlife Refuge, P.O. Box 1610, Alturas, CA 96101; (530) 233-3572; http://refuges.fws.gov/profiles/ index.cfm?id=11690. Office hours, 7:30 am-4:00 pm. Refuge is open during daylight hours. Good access roads. Nearest main highway is U.S. 395. Nearest community is Alturas. Refuge waters include Dorris Reservoir (approximately 1,000 acres. when at full capacity) which is open to fishing February-September 30. Walk-in access only is available February 1-March 31. Boat access is open April 1-September 30. Available species include largemouth bass, catfish, sunfish and rainbow trout.



Sacramento River National Wildlife Refuge, Packer Unit, managed as part of the Sacramento NWR Complex, 752 County Rd. 99W, Willows, CA 95988; (530) 934-2801; http://refuges.fws.gov/ profiles/index.cfm?id=11627. Office hours, 7:30 am-4:00 pm. Refuge is open sunrise to sunset. Nearest community is Ordbend. Nearest highway is Hwy. 45. The Packer Unit contains a 100-acre oxbow lake. Best time for angling is March-November for species such as bluegill and largemouth bass. A narrow dirt road provides access to an unimproved boat launch area. There is limited fishing from the shoreline. No facilities are available.

Salinas River National Wildlife Refuge, c/o San Francisco Bay NWR Complex, P.O. Box 524, Newark, CA 94560; (510) 792-0222; http://refuges.fws.gov/profiles/index.cfm?id=11642. Office hours (at San Francisco Bay NWR), 10:00 am-5:00 pm, except closed on all federal holidays. Salinas River NWR is open during daylight hours. Primitive access roads. Nearest main highway is Hwy. 1. Nearest communities are Seaside and Monterey. Salinas River NWR provides access to surf fishing via a 1/3-mile trail. Waters include the mouth of the Salinas River and Monterey Bay, with approximately 1 mile of shoreline open to surf fishing. Fishing is primarily for sea perch and shark. There are no facilities on Salinas River NWR.

Refuge is open a half-hour before sunrise to a half-hour after sunset. Good access roads. Nearest main highways are I-5, Hwys. 99, 165 and 152. Nearest community is Los Banos. Refuge waters include Salt Slough and the San Joaquin River on the east side of Hwy. 165. The fishing season is year-round. Available species include striped bass, crappie and catfish. No boats are allowed.



San Pablo Bay National Wildlife Refuge, c/o San Francisco Bay NWR Complex, P.O. Box 524, Newark, CA 94560; (510) 792-0222; http://refuges.fws.gov/profiles/index.cfm?id=11644. Office hours (at San Francisco Bay NWR Complex), 10:00 am–5:00 pm, except closed on all federal holidays. San Pablo Bay NWR is open yearround during daylight hours. Nearest main highway is Hwy. 37. Nearest community is Vallejo. Fishing season is year-round by boat only on all open waters and navigable sloughs of the refuge, including lower reach of Tolay Creek and all of the northern portion of San Pablo Bay. No shoreline fishing is currently permitted. Saltwater species include flounder, striped bass, sturgeon, rays and sharks. Boat ramps are located in Vallejo, on the Napa and Petaluma Rivers.

Office hours, 7:00 am-3:30 pm, Monday-Friday. Refuge is open during daylight hours. Good access roads. Nearest main highways are Hwys. 111 and 86. Nearest communities are Niland, Calipatria, Westmoreland and Brawley. Refuge waters include Salton Sea, a saltwater inland "lake," saltier than the ocean. There are approximately 35,500 acres of refuge lake area open to fishing, with water ranging from shallow to about 20 feet deep. Fishing season is year-round. Available species include orangemouth corvina, sargo, gulf croaker and tilapia. Boat fishing only is permitted.



Tijuana Slough National Wildlife Refuge, P.O. Box 334, Imperial Beach, CA 91933; (619) 575-1290; http://refuges.fws.gov/profiles/index.cfm?id=11681. Office hours, 7:30 am-4:00 pm, Monday-Friday. Refuge is open during daylight hours. Good access roads. Nearest main highway is I-5. Nearest community is Imperial Beach. Surf fishing access is below mean High Tide Line, but angler walk-in access is permitted through refuge. Fishing season is year-round. Available species include surf perch, croaker, corvina and California halibut. No boats are permitted. No fishing is allowed at the Tijuana River mouth, in the lagoon, sloughs or marsh areas. Fishing is permitted only in the ocean.

Refuge is open during daylight hours. Good access roads. Nearest main highway is U.S. 97. Nearest community is Klamath Falls. Refuge waters include Upper Klamath Lake. Fishing season is year-round. Freshwater species include rainbow trout. The lake is covered in winter with thin ice.



### **HAWAII**

Refuge is open during daylight hours. Good access roads. Nearest main highway is Hwy. 56. Nearest community is Hanalei. Refuge waters include Hanalei River. Fishing season is year-round; March-September for mullet. Other available species include milkfish, barracuda, mobi and shrimp.



Kakahaia National Wildlife Refuge, Island of Molokai, HI, Maui NWR Complex, PO. Box 1042, Milepost 6 Mokulele Hwy., Kihei, HI 96753; (808) 875-1582; http://refuges.fws.gov/profiles/index.cfm?id=12525. Office hours, 8:00 am-4:00 pm, daily. Access is for coastal area only located along Kamehameha V Highway (Hwy. 450). The nearest community is Kaunakakai. Refuge property includes approximately 1 mile of shoreline. Most common species in the ocean are omilu, weke a'a weke pueo, goatfish, hawkfish, surgeonfish, lai, kaku and snapper. Invertebrates most commonly taken include tako and ghost crab. No boats are permitted.



Kilauea Point National Wildlife Refuge, managed as part of the Kauai NWR Complex, Kilauea Rd., Kauai, HI; (808) 828-1413; http://refuges.fws.gov/profiles/index.cfm?id=12530. Office hours, 10:00 am-4:00 pm, daily. Nearest community is Kilauea. Surf fishing along the tidal shoreline from Rock Quarry to Mokolea Point is for various salt water species, including ulua, papio, barracuda and others. Fishing is allowed during daylight hours. There are no public facilities in this area of the refuge.



## **IDAHO**

Refuge waters open to fishing include Outlet Canal-A, a channelized portion of the Bear River (2 miles long, approximately 12 surface acres). Available species include brown and cutthroat trout, yellow perch and carp. Boat fishing is not allowed.



Deer Flat National Wildlife Refuge (Lake Lowell Sector, Idaho), 13751 Upper Embankment Rd., Nampa, ID 83686; (208) 467-9278; http://refuges.fws.gov/profiles/index.cfm?id=14560. Office hours, 7:30 am-4:00 pm, Monday-Friday. Refuge is open daily. Good access roads. Nearest main highways are I-84, Hwys. 45 and 55. Nearest communities are Nampa-Caldwell and Boise. Refuge waters include Lake Lowell (8,800 acres). Fishing season is year-round with seasonal restrictions. Available species include rain-bow trout, largemouth bass, smallmouth bass, crappie, bluegill, yellow perch and catfish. Power craft are permitted April 15-October 1.



Deer Flat National Wildlife Refuge (Snake River Islands Sector, Idaho and Oregon), 13751 Upper Embankment Rd., Nampa, ID 83686; (208) 888-5582; http://refuges.fws.gov/profiles/index.cfm? id=14560. Office hours, 7:30 am-4:00 pm, Monday- Friday. Good access road. Nearest main highway is I-84. Nearest communities are Ontario, OR, and Payette, Nyssa and Weiser, ID. Refuge waters include Snake River. Fishing season is year-round. Available species include largemouth bass, smallmouth bass, crappie, bluegill and catfish. Refuge islands are available by boat only. Islands are closed February 1-May 31.



Kootenai National Wildlife Refuge, HCR 60, Box 283, Bonners Ferry, ID 83805; (208) 267-3888; http://refuges.fws.gov/profiles/index.cfm?id=14580. Office hours, 8:00 am-4:30 pm, Monday-Friday. Refuge is open during daylight hours. Good access roads. Nearest main highway is U.S. 95. Nearest communities are Bonners Ferry and Sandpoint. Refuge waters include 2.5 miles of stream, approximately 4 acres. Fishing season is generally late May-November. Available species include rainbow and brook trout.



Minidoka National Wildlife Refuge, 961 E. Minidoka Dam Rd., Rupert, ID 83350; (208) 436-3589; http://refuges.fws.gov/profiles/ index.cfm?id=14614. Office hours, 8:00 am-4:30 pm, Monday-Friday. Refuge is open during daylight hours. Access roads vary from good to primitive. Nearest main highways are I-84, I-86 and Hwy. 24. Nearest community is Rupert. Refuge waters include Lake Walcott; the reservoir behind Minidoka Dam (11,000 acres, of which 4,000 acres are open to boat fishing at certain times); Snake River, in the spillway area below Minidoka Dam (60 acres); and in Smith Spring and Gifford Spring boat-fishing lanes (80 and 200 acres, respectively). Boat fishing on Lake Walcott is permitted April 1-September 30 within the area designated by buoys. Boat fishing within the Smith Spring and Gifford Spring boatfishing lanes is permitted year-round. Bank fishing is also permitted year-round. Available species include rainbow trout and smallmouth bass. In parts of the refuge, stay on designated access roads to protect fragile sagebrush-grassland habitat.

Fishing season is year-round, except North Marsh is closed during waterfowl hunting season. Available species include largemouth bass, crappie, bluegill, bullhead and carp. Electric motors only are allowed.

Ruby Lake National Wildlife Refuge, HC 60 Box 860, Ruby Valley, NV 89833; (775) 779-2237; http://pacific.fws.gov/refuges/field/NV\_rubylk.htm. Office hours, 7:00 am—4:00 pm. Refuge is open 1 hour before sunrise until 2 hours after sunset. Fair access roads; 30-35 miles are dirt/gravel. Nearest main highways are U.S. 50, 93 and I-80. Nearest community is Elko. Refuge waters

include South Marsh; Units 10, 13, 14, 20 and 21; Gravel Pit Pond; Willow Pond; North County Line Pond; and Hidden Springs Pond. (Note that there are no open-water lakes, only wetlands interspersed with cattails and bulrush, which form a maze of channels.) Fishing season is year-round. Species include rainbow, brook, cutthroat and brown trout as well as largemouth bass. No boats are permitted January 1-June 14; non-motorized boats and boats with battery-powered electric motors are permitted June 15-July 31; non-motorized boats and boats propelled by gas motors 10 hp or less are permitted August 1-December 31.

Nearest highway is U.S. Hwy. 101. Primary fishing is shellfishing on refuge mudflats. Fishing season is year-round.

Office hours, 7:00 am-4:30 pm Monday-Thursday, 7:00 am-3:30 pm Friday. Poor access roads. Nearest main highways are U.S. 395 and Hwy. 140. Fishing is available in Rock and Guano Creeks and Warner Pond. Nearest community is Lakeview.

Office hours, 7:00 am-4:30 pm, Monday-Thursday; 7:00 am-3:30 pm, Friday. The refuge is open from dawn to dusk. Good access roads. Nearest main highway is Hwy. 78. Nearest community is Princeton. Anglers may fish year-round from Page Dam to the confluence of the Blitzen River and Bridge Creek on the following waterways: Blitzen River, East Canal, Mud Creek and Bridge Creek. Anglers may fish on Krumbo Reservoir from the fourth Saturday in April until the end of October. Available species are primarily crappie, largemouth bass, rainbow trout and redband trout. Non-motorized boats and boats with electric motors are authorized on Krumbo Reservoir.

McKay Creek National Wildlife Refuge, managed as part of the Mid-Columbia River NWR Complex, Po. Box 2527, Pasco, WA 99302; (509) 545-8588; http://refuges.fws.gov/profiles/index.cfm?id=13582. Office hours, 8:00 am-4:00 pm, Monday-Friday. Refuge is open 24 hours a day during fishing season. Fair access roads. Nearest main highway is Hwy. 395. Nearest community is Pendleton. Fishing on the refuge is at the McKay Creek Reservoir, which consists of 1,300 acres of water at full pool and decreases to an average of 250 acres of water by late September. Fishing is available March 1-September 30. Available species include rainbow trout, crappie, black bass, sunfish and yellow perch. The refuge's facilities include a seasonal boat launch.

Refuge waters include small gravel ponds and a lake created by a hydroelectric dam on the Columbia River. Fishing is available March 1-September 30. The sloughs on the McCormack Unit are closed to fishing to protect fragile waterfowl habitat. Available species include steelhead, salmon, largemouth bass, small-mouth bass, crappie, bluegill, perch, walleye, catfish and sturgeon.

Freshwater species include rainbow trout, largemouth bass, crappie, sunfish and yellow perch. Only motorless boats are permitted on Big Springs Reservoir and only float tubes on Dufurrena Ponds. Catnip Reservoir (120 acres) is also open September 1-November 15. This is catch and release only, with only single barbless hooks for cutthroat trout.



Umatilla National Wildlife Refuge, managed as part of the Mid-Columbia River NWR Complex, is located near Irrigon, OR and Paterson, WA. Fishing, boats or other flotation devices are not allowed on impoundments on and along Crab Creek in Marsh Units I and II. Both powered and non-powered boats are allowed on all other waters open for fishing, except use of gasoline motors is prohibited on Upper and Lower Hampton, Hutchinson and Shiner Lakes.

Refuge waters include Outlet Creek. Season usually runs from June 1-October 31. Available species include brook and rainbow trout and bullhead. No boats are permitted.



Dungeness National Wildlife Refuge, managed as part of the Washington Maritime NWR Complex, 33 South Barr Rd., Port Angeles, WA 98362; (360) 457-8451; http://refuges.fws.gov/profiles/index.cfm?id=13539. Office hours, 7:30 am-4:00 pm, Monday-Friday. Nearest community is Dungeness. Nearest highway is Hwy. 101. Available species include Chinook and Coho salmon, flounder and shellfish. State seasonal fishing regulations apply, as do periodic health closures on the shellfish fisheries. The refuge is open during daylight hours. Refuge waters are closed to all uses October 1-May 14. Public boat launch is available off Marine Drive.



**Hanford Reach National Monument/Saddle Mountain National** Wildlife Refuge, 3250 Port of Benton Blvd., Richland, WA 99354; (509) 371-1801. For more information, go to http://hanfordreach. fws.gov/. Special angling highlights are the nation's largest remaining Columbia River fall Chinook salmon run and sturgeon population. Available species include largemouth and smallmouth bass, and steelhead. Methods generally involve motorboat trolling or drifting, and bait and fly fishing from the river shore. The refuge's facilities for anglers are a narrow, 2-lane concrete ramp at the White Bluffs launch. Primitive launches are located just downstream of the Monument at the Washington Department of Fish and Wildlife's Ringold Fish Hatchery, and near the Vernita Bridge rest area. Developed launches are available downstream of the monument in Richland, Kennewick and Pasco city parks. Fishing season is year-round.

Columbia River. Fishing season is generally open for at least one species year-round. Species include Chinook and Coho salmon and sturgeon.

Fishing opportunities include 3 lakes and the Little Pend Oreille River. Bayley Lake (50 acres) and McDowell Lake (47 acres) are fly-fishing only, primarily catch and release, and only non-motorized boats are allowed. Potter's Pond (15 acres) has a 5-fish limit, and electric motors are allowed. The Little Pend Oreille River (9.9 miles) is selective gear only and mostly catch and release.



Non-motorized boats and electric trolling motors may be used on all open portions of the refuge, including the eastern 4-mile stretch of the river. Where sections of the river border private property, only the half of the river adjacent to public property is open to public use.

Bank fishing on these lakes is open year-round. Boat fishing is permitted May 1-September 30. Ice fishing is also permitted on these two lakes. A portion of Lake Tewaukon is closed to ice fishing east of the point. The refuge's facilities include a boat ramp, fish-

ing piers and restrooms. There are size limits for pike and walleve on these lakes.

Visitor center hours, 8:00 am-4:30 pm. District is open sunrise to sunset. Tewaukon WMD encompasses over 13,000 acres of waterfowl production areas in three counties, Ransom, Sargent, and Richland. The fishing opportunities on most wetland management districts are marginal but are offered in accordance with state seasons. Species found include fathead minnows, perch and northern pike.



**Upper Souris National Wildlife Refuge**, 17705 212th Ave. NW, Foxholm, ND 58718; (701) 468-5467; http://refuges.fws.gov/profiles/index.cfm?id=62680. Office hours, 8:00 am-4:30 pm, Monday-Friday, except for federal holidays. Refuge is open 5:00 am-10:00 pm daily. Nearest communities are Burlington and Minot. Nearest highways are Hwy. 52 and Hwy. 83. Upper Souris NWR has one of the best year-round fisheries in north-central ND. Anglers may fish for walleyes, northern pike, yellow perch and smallmouth bass in Lake Darling and the Souris River. Thirteen bank fishing areas and 2 boat fishing areas are available. Motorboats are permitted on Lake Darling for fishing only.



Valley City Wetland Management District is managed as part of Arrowwood NWR Complex, 11515 River Road, Valley City, ND 58072; (701) 845-3466; http://refuges.fws.gov/profiles/index.cfm? id=62532. Office hours, 7:30 am-4:00 pm, Monday-Friday. District is open dawn to dusk. Nearest highway is I-94. Nearest community is Valley City. Fishing season is in accordance with state regulations. Fishing opportunities in the district are marginal but may include walleye, yellow perch and northern pike. There are no facilities for anglers, and vehicle access is limited to designated trails.

District is open 24 hours. The fishing opportunities in the Huron WMD are marginal but are offered in accordance with state seasons. Species found include northern pike, walleye, crappie and perch.

to sunset. There are fair access roads. Nearest main highways are Hwys. 18 and 73. Nearest community is Martin. Refuge waters include 1 lake (167 acres), 2 ponds (5 acres) and 3 wetlands (3,000 acres total). The fishing season is open year-round, with ice fishing in winter. Available species include rainbow trout, largemouth and, smallmouth bass, crappie, bluegill, yellow perch, northern pike and sauger. "No wake restriction" for boats and slot limit on northern pike apply. Game fish populations vary considerably from year to year and season to season.

The fishery is cyclical-when water quality is poor, fishing opportunities may be limited to carp and bullhead, but when water quality is excellent, the fishery can support largemouth bass. Water levels vary considerably. Small boats may be launched when the lake is near capacity. A handful of lakes on the wetland management district support a sport fishery. These fisheries are also cyclical.

Office and visitor center hours, 8:00 am-4:30 pm, Monday-Friday. The refuge is open daylight hours only. Nearest communities are Aberdeen and Bath Corner. Nearest highway is State Hwy. 12. Sand Lake offers year-round fishing at five specified locations around the refuge. These include the Bridge Crossing Area; Hecla Day Use Area; Bridge Crossing Area on State Hwy. 10; Bridge Crossing Area; and the Bridge Crossing Area on Brown County Hwy. 16. Available species include northern pike, walleye and perch. Boats are not permitted. During times of open water, anglers must fish from shore, and ice shacks must be removed daily. Winterkill can occur during low water years. In some years, special James River regulations may be in effect.





























Sand Lake Wetland Management District encompasses 8 counties in northeast SD: Brown, Spink, Faulk, Edmunds, McPherson, Campbell, Walworth and Potter. A number of waterfowl production areas around the district hold quality fishing opportunities for walleye, pike, perch, bluegill, bass and other species of fish. Fishing season is in accordance with state regulations. Vehicles are prohibited.



Waubay National Wildlife Refuge, 44401 134A St., Waubay, SD 57273; (605) 947-4521; http://refuges.fws.gov/profiles/index.cfm? id=64590. Office hours, 8:00 am-4:30 pm. Refuge is open during daylight hours. Nearest community is Waubay. Nearest highway is Hwy. 12. The primary fishing opportunities include 2,500 acres of ice-fishing for walleye, perch and northern pike. Fishing is limited to winter daylight hours for walk-in travel. There are special lake regulations for limits on yellow perch and walleye size and limit restrictions.



Waubay Wetland Management District includes 200 individual waterfowl production areas scattered over 6 counties in northeastern SD. Nearest communities are Ouray and Vernal. Nearest highways are Hwy. 40 and Hwy. 88. Refuge is open daily from 1 hour before sunrise to 1 hour after sunset. Fishing is permitted along numerous access points on the Green River. Fishing season is in accordance with state regulations. The primary fishing is in the Green River for catfish, smallmouth bass and, occasionally, northern pike. The refuge's facilities for anglers include a boat ramp located 1 mile upstream from the refuge headquarters and numerous parking areas along the refuge tour route.

Refuge waters include North Park Pond (1 acre), Gros Ventre River (approximately 8 miles), Upper and Lower Flat Creek (approximately 5 miles) and Nowlin Creek (1/2 mile). Fishing is available at North Park Pond all year; Upper Flat Creek and Gros Ventre River, April 1-October 31; and Lower Flat Creek and Nowlin Creek, August 1-October 31. Lower Flat Creek is a popular meandering meadow stream. Lower Flat Creek and Nowlin Creek are fly-fishing-only streams with special regulations. Available species include brook trout and native Snake River cutthroat. Use of boats or other floating devices is prohibited.

The refuge's facilities include 4 boat ramps. Vehicle travel is restricted to designated refuge roads. The Green River is a shallow, swift river with many rocks hidden beneath the surface. It is best suited for canoes, drift boats and rafts; motors are not recommended. Personal watercraft, airboats and jet boats are prohibited.

The refuge encompasses off-shore islands and remote coastal areas, from Cape Lisburne on the Chukchi Sea to the tip of the Aleutians and eastward to Forrester Island on the border of British Columbia. Only the visitor center on the Sterling Hwy, in Homer is accessible by car. The refuge has more salmon streams than any other refuge in the country, but they are all very remote, short and not suitable for boating. The best refuge stream fishing opportunities for salmon and Dolly Varden are in the Aleutian Islands. The easiest access is by ferry or plane to Dutch Harbor/Unalaska or by plane to Adak. The best saltwater opportunities on the refuge for halibut, silver salmon and cod are the marine waters of Afognak Island, reachable by float plane or boat from Homer or Kodiak. These refuges are located along the southeastern 2/3 of the Alaska Peninsula, encompassing the Aleutian Range. All 5 species of Pacific salmon are available in the freshwater streams and lakes, plus arctic char, rainbow and lake trout, grayling, Dolly Varden, northern pike and burbot. Saltwater species include flounder and halibut. The refuges include numerous ponds, lakes, rivers, streams and estuaries. Becharof Lake is 290,000 acres. There is year-round fishing at the refuges. Airboats are prohibited.



Arctic National Wildlife Refuge, 101 12th Ave. Room 236, Box 20, Fairbanks, AK 99701; (907) 456-0250. Office hours, 8:00 am-5:00 pm, Monday-Friday. Refuge is open 24 hours. Nearest communities are Kaktovik and Arctic Village. The refuge is especially noted for wilderness fishing on rivers from the Brooks Range Mountains, north to the Beaufort Sea. Species include Dolly Varden, arctic grayling, arctic char, lake trout and arctic cisco. Species from the Brooks Range, south include arctic grayling, northern pike, burbot, broad whitefish and, occasionally, Chinook, Coho and chum salmon. Fishing is year-round, but lakes and rivers are ice-covered for 7 months of the year. Access is by charter aircraft. For more information, visit http://arctic.fws.gov/

The largest river is the Yukon River, which forms the western boundary of the refuge. The refuge includes a large portion of the upper Innoko River basin. Fishing season is open year-round, except for some salmon. There is excellent northern pike fishing. Other species include king, silver, pink and chum salmon, Dolly Varden, inconnu, arctic grayling, northern pike, burbot and several species of whitefish. Airboats are prohibited. There are no medical or emergency facilities available.

From Cold Bay, local access to a small portion of the refuge is possible via a local network of established roads. Refuge lands encompass numerous ponds, lakes, rivers and streams and extensive coastal estuaries. Specific fishing seasons vary. Peak period for salmon species is August-October. Available species include arctic char, Dolly Varden, steelhead trout and sockeye, Coho, chum, pink and some Chinook salmon. Saltwater species include Pacific halibut, flounder and Pacific cod.

Sixteen species of fish inhabit the lakes and rivers, including Chinook, Coho and chum salmon, which are common in the larger lakes and rivers, while grayling are more abundant in smaller streams. Catch and release is encouraged. Airboats are prohibited.

Tustumena and Skilak lakes, at 73,000 and 25,000 acres, respectively, are among the largest in Alaska. There is good salmon fishing in the Kasilof. Swanson, Russian and Kenai rivers. Fishing is generally yearround, with the exception of some salmon. The Kenai River holds the world record for king and red salmon taken by rod and reel. Species available include silver, pink, king and red salmon, rainbow trout, arctic char, Dolly Varden, lake trout, steelhead, kokanee and grayling. Charter aircraft are available. Steelhead, rainbow trout, Dolly Varden and arctic char are also abundant. Fishing is year-round, except for some salmon. Most prime salmon fishing rivers are also Kodiak brown bear concentration areas, so knowledge of bear safety is critical. Airboats, helicopters, all-terrain vehicles or any other vehicles incompatible with wilderness areas are prohibited on the Kodiak NWR. Access to the Karluk River drainage by unguided visitors is conditional on carrying a limited entry permit between June 10 and July 15 and a registration permit the rest of the year. The primary fishing opportunities are for arctic char, inconnu, chum, burbot, whitefish, grayling and northern pike. Inconnu weighing 40-50 pounds are not uncommon. Saltwater species include flounder, rainbow smelt, Arctic cod, saffron cod and starry flounder. Fishing is generally year-round, with the exception of some salmon. Anglers come from around the world to fish for Chinook, Coho, sockeye, chum and pink salmon, arctic gravling, rainbow and lake trout, Dolly Varden, arctic char and northern pike. Fishing is open year-round for most species, but the majority of fishing occurs June-September, when salmon are available. Some refuge waters are artificial-lure-only areas, and some have catch-and-release requirements for some species. Many saltwater species inhabit the refuge's coastline, but few sport anglers venture into the hazardous ocean conditions that are common in this area of the Bering Sea. The refuge has no developed facilities. Most anglers float the rivers or access them by motorboat. Access to the refuge is by aircraft, which can be chartered in nearby Dillingham or Bethel. There are a king salmon stamp requirements and catch-andrelease regulations for rainbow trout for non-residents on certain rivers.
