## UNANIMOUS CONSENT AGREEMENTS

### H.R. 2669 (ORDER NO. 269)

1.—*Ordered*, That at 10:00 a.m. on Thursday, July 19, 2007, the Senate resume consideration of H.R. 2669, an act to provide for reconciliation pursuant to section 601 of the concurrent resolution on the budget for fiscal year 2008.

*Ordered further*, That at 12 noon on Thursday, July 19, 2007, the Senate resume consideration of Amdt. No. 2329 offered by the Senator from Alaska (Ms. Murkowski) and Amdt. No. 2330, offered by the Senator from Massachusetts (Mr. Kennedy), that there then be 2 minutes of debate equally divided prior to a vote in relation to each amendment and that the Senate vote first in relation to Amdt. No. 2329, and that no amendment be in order to either amendment prior to the vote.

*Ordered further*, That when the Senate resumes consideration of the bill on Thursday, there be 10 hours of debate remaining and that the time be equally divided and controlled.

*Ordered further*, That notwithstanding time remaining on the substitute amendment (Amdt. No. 2327), it be in order to offer amendments thereto. (*July 18, 2007.*)

### H.R. 2638 (ORDER NO. 206)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 2638, an act making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2008, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*July 18, 2007.*)

### VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

*Ordered further*, That the message be held at the desk. (*June 20, 2007.*)

### CONFERENCE REPORT ON H.R. 1

4.—*Ordered*, That with respect to H.R. 1, the Implementing the 9/11 Commission Recommendations Act of 2007, it not be in order to consider the conference report thereon if it contains the collective bargaining provisions that the Majority Leader has committed to drop. (*July 9, 2007.*)
