UNANIMOUS CONSENT AGREEMENTS

H.R. 6 (ORDER NO. 9)

1.—*Ordered*, That at 10:30 a.m., on Thursday, June 21, 2007, the Senate resume consideration of H.R. 6, an act to reduce our Nation's dependency on foreign oil by investing in clean, renewable, and alternative energy resources, promoting new emerging energy technologies, developing greater efficiency, and creating a Strategic Energy Efficiency and Renewables Reserve to invest in alternative energy, and for other purposes, and that there be 70 minutes for concurrent debate in relation to Amdt. No. 1733, as modified, offered by the Senator from Arizona (Mr. Kyl) and on the cloture motion on Amdt. No. 1704, offered by the Senator from Montana (Mr. Baucus), with the time equally divided and controlled by the Senators Kyl and Baucus, or their designees.

Ordered further, That there be 35 minutes for debate on Amdt. No. 1733 and 35 minutes for debate on the cloture motion on Amdt. No. 1704, and that the Senator from Arizona (Mr. Kyl) control 15 minutes and the Senior Senator from New Mexico (Mr. Domenici) control 20 minutes.

Ordered further, That no other amendment be in order prior to the vote on Amdt. No. 1733, and that upon the use or yielding back of time, the Senate proceed to vote in relation to Amdt. No. 1733, and that upon disposition of the amendment, the Senate proceed to a vote on the motion to invoke cloture on Amdt. No. 1704.

Ordered further, That Senators have until 11 a.m., on Thursday, June 21, 2007, to file second degree amendments to Amdt. No. 1704.

Ordered further, That with respect to the cloture motions filed on Amdts. No. 1704 and 1502, and on the bill, the mandatory quorum calls under Rule XXII be waived. (*June 19, 20, 2007.*)

H.R. 800 (ORDER NO. 66)

2.—*Ordered*, That relative to the cloture motion filed on the motion to proceed to H.R. 800, an act to amend the National Labor Relations Act to establish an efficient system to enable employees to form, join, or assist labor organizations, to provide for mandatory injunctions for unfair labor practices during organizing efforts, and for other purposes, the mandatory quorum under Rule XXII be waived. (*June 19, 2007.*)

S. 1639 (ORDER NO. 208)

3.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 1639, a bill to provide for comprehensive immigration reform and for other purposes, the mandatory quorum call under Rule XXII be waived. (*June 20, 2007.*)

VETO MESSAGE ON S. 5

4.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)
