**UNANIMOUS CONSENT AGREEMENT**

S. 1348 (ORDER NO. 144)

*Ordered*, That on Tuesday, May 22, 2007, following the conclusion of Morning Business, the Senate resume consideration of S. 1348, a bill to provide for comprehensive immigration reform, and for other purposes; provided that the Senator from Alabama (Mr. Sessions) be recognized and have up to 2 hours under his control, and that no amendments be in order during this period; further, that if the Senator from Alabama (Mr. Sessions) has not used all of his time prior to the 12:30 p.m. recess, that he then be recognized at 2:15 p.m. (*May 14, 21, 2007.*)
