UNANIMOUS CONSENT AGREEMENT

S. CON. RES. 21 (ORDER NO. 82)

Ordered, That on Friday, March 23, 2007, when the Senate resumes consideration of S. Con. Res. 21, an original concurrent resolution setting forth the congressional budget for the United States Government for fiscal year 2008 and including the appropriate budgetary levels for fiscal years 2007 and 2009 through 2012, there be 30 minutes remaining for debate, equally divided and controlled between the Chair and Ranking Member of the Budget Committee.

Ordered further, That Amdt. No. 583 offered by the Senator from Arizona (Mr. Kyl) be voted on at a time to be determined by the Leaders but before 11:00 a.m., on Friday, March 23, 2007, and that there be 6 minutes equally divided before a vote in relation to the amendment and that the Majority have the right to offer a competing first degree amendment on which there shall also be 6 minutes equally divided prior to a vote in relation thereto.

Ordered further, That when voting begins, there be 2 minutes of debate equally divided prior to each vote. (*Mar. 22, 2007.*)
