UNANIMOUS CONSENT AGREEMENT

S. 761 (ORDER NO. 70)

Ordered, That on Wednesday, April 25, 2007, when the Senate resumes consideration of S. 761, a bill to invest in innovation and education to improve the competitiveness of the United States in the global economy, there be 30 minutes of debate with respect to Amdt. No. 938 offered by the Senator from New Hampshire (Mr. Sununu), with the time equally divided and controlled by the Senator from New Hampshire (Mr. Sununu) and the Senator from Massachusetts (Mr. Kennedy) or their designees; that upon the use or yielding back of time, the Senate proceed to vote in relation to Amdt. No. 938, with no amendment in order to the amendment prior to the vote. (*Apr. 24, 2007.*)
