### Pilot with NIST/FPKISC using SingleSignOn.Net digital certificates:

The FPKISC has entered into a pilot with NIST to give FPKISC members SingleSignOn.Net digital certificates to use and access secure web pages on the FPKISC web site. This pilot should last approximately 6 months to a year.

A representative from Digital Signature Trust Co and a representative from SingleSignOn.Net briefed us on their appliance and how we can access our digital certificates.

### Open Source Software for e-Government:

The Cyberspace Policy Institute of The George Washington University will have demonstrations of mature Open Source programs every month in conjunction with the General Services Administration at NSF facilities. A Q&A session will follow the presentations.
