The enclosed report documents an inspection related to public health and safety, led by Mr. D. Silk at Lycoming, New York. The inspection at the James A. Fitzpatrick Nuclear Power Plant evaluated the performance of your emergency response organization (ERO) during the July 19, 2001, partial-participation exercise, the post-exercise critique, and the emergency preparedness performance indicators as specified in the reactor oversight program. The inspectors discussed the findings of this inspection with you and other members of your staff on July 23, 2001, via tele-conference.

This inspection was an examination of activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspection consisted of a selected examination of procedures and representative records, observations of activities, and interviews with personnel.

No violations of NRC requirements or significant findings were identified. No response to this letter is required.

## 1EP1 Exercise Evaluation

## a. <u>Inspection Scope</u>

The inspectors reviewed and assessed:

- Exercise objectives and scenario to determine if the exercise would test major elements of the licensee's emergency plan as required by 10 CFR 50.47(b)(14).
- The licensee's overall exercise performance in the following emergency response facilities: simulator control room, the technical support center, the operations support center, the emergency operations facility, and the joint news center.
- The licensee's exercise performance by primarily focusing on the implementation of the risk-significant planning standards (RSPS) in 10 CFR 50.47 (b) (4), (5), (9) & (10) which are emergency classification, offsite notification, radiological assessment, and protective action recommendations (PARs), respectively.
- Other performance areas besides the RSPS, such as the emergency response organization's (ERO) recognition of abnormal plant conditions, command and control, intra- and inter-facility communications, prioritization of mitigation activities, utilization of repair and field monitoring teams, interface with offsite agencies, and the overall implementation of the emergency plan and implementing procedures.
- The post-exercise critique to evaluate the licensee's self-assessment of their ERO performance during the exercise.

Performance related to the above areas was evaluated against the licensee's emergency plan commitments and implementing procedures, as well as the planning standards of 10 CFR 50.47 (b) and the requirements of 10 CFR 50 Appendix E.

No findings of significance were identified.

#### a. Inspection Scope

The inspector conducted an in-office review of licensee submitted changes for the emergency plan-related documents listed below to determine if the changes decreased the effectiveness of the plan as stated in 10 CFR 50.54(q). Licensee data was assessed against the guidance in NEI 99-02 Revision 1, Regulatory Assessment Performance Indicator Guide.
