On October 3, 2003, the NRC completed an inspection at your North Anna Power Station. The enclosed report documents the inspection findings which were discussed on October 3, 2003, and March 17, 2004, with Mr. D. Heacock and other members of your staff.

The inspection examined activities conducted under your license as they relate to public health and safety, the common defense and security, and to compliance with the Commission's regulations, orders, and the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.
