On May 3, 2004, the NRC completed an in-office inspection related to your Sequoyah Nuclear Power Plant. The enclosed report documents the inspection details which were discussed on May 3, 2004, with Mr. R. Beecken and other members of your staff.

The inspection examined activities conducted under your licenses as they relate to public health and safety, the common defense and security, and compliance with the Commission's regulations, orders, and the conditions of your licenses. The inspector reviewed selected procedures and records as part of this inspection effort.
