Thanks to everyone for your participation in the TRT meeting on Thursday and Friday. For those of you not able to attend, the group was able to complete the evaluation process for all 68 Washington salmonid populations historically in the WLC area. This memo includes action items discussed during the meeting.

I. UPCOMING MEETING DATES

The next TRT meeting will be focused on the Oregon populations and will take place in Oregon (location to be determined) on December 4 and 5. While the group spent a few minutes discussing the 2004 TRT schedule, no meeting dates were set. The group agreed to spend some time at the December meeting discussing future agenda items and asked JJ to send out calendars for the early part of next year in order to identify possible meeting dates.

Paul McElhany reminded TRT members that the meeting with the LCFRB to discuss TRT comments on their draft technical foundation is set for Thursday, November 13 from 9:00 a.m. – 2:00 p.m. The meeting will take place in the LCFRB Longview office. II. POPULATION SCORING EFFORTS

NWFSC staff distributed packets of information for each ESU with individual sections for each population (NOTE: for those of you not in attendance, these will be sent to you in the near future). To begin the scoring efforts, Paul McElhany described the general methods used to

create the summary tables, figures, and maps included with each population. This was described in a separate document, which will be distributed by email.

The group present scored all 68 populations during the two days and reviewed these initial results. During the course of their deliberations, a number of issues were identified (e.g., the data available for review did not include recent information; different approaches to assessing diversity; different approaches to assessing habitat) which the group felt should be captured in a memo to be included with the final versions of the population status summaries. In addition, during the course of scoring the populations, each member had the opportunity to incorporate notes for further consideration. Jim Myers agreed to capture the major issues as well as the notes in a draft memo for review by other TRT members prior to broader distribution.
