Qualitative benefits indicate significant performance improvements as measured by benefit reach (dispersion across DOJ) and impact (degree of improvement) measured across each of the UFMS goals.

UFMS will result in multiple qualitative benefits that directly support the President's Management Agenda (as described above) and the performance measures listed in Section D.

-UFMS will support DOJ Mission and Business Results by improving resource productivity. Standardization of data elements, for example, eliminates translation or data conversion by managers in order to get a consistent view of financial performance across Components. Eliminating extra steps in analysis process decreases manpower requirements and improves quality and accuracy.
