

END USER LICENSE AGREEMENT - ALLOCATE

IMPORTANT: DO NOT USE THE ENCLOSED MEDIA PACKAGE UNTIL YOU HAVE READ AND AGREED TO THIS LICENSE AGREEMENT.

This is a legal agreement between you, the end user ("Licensee") and the United States Bureau of the Census ("BOC") The BOC has entered into a contract with Computer and Hi-Tech Management, Inc., a Virginia corporation ("Contractor") for the procurement of the software licensed hereunder. Contractor has entered into a subcontract with SRC, LLC, a California limited liability company ("SRC"), to develop the software licensed hereunder ("Licensed Software"). The Licensed Software is based on SRC's Allocate, and is SRC's proprietary intellectual property.

If you have purchased this product in media form, by opening the media wrapper and installing the product on your computer, you are deemed to accept the terms of this License Agreement. If you do not agree to the terms of this License Agreement, then terminate the operation, remove the media from your computer, and return it to the BOC. If you have purchased this product on line and have downloaded it, by selecting OK you are consenting to the terms of this License. If you do not agree to the terms of this License Agreement, press CANCEL.

1. DEFINITIONS: As used in this License Agreement, "Allocate" or "Licensed Software" means the Licensed Software and demographic data files and information contained on the media provided with this package, or downloaded. The Licensed Software is proprietary to SRC or to SRC's licensors. "Computer" means mainframe or personal computers, hand held computers, personal digital devices and all other such apparatus capable of operating or accommodating the operation of Allocate. "Copies" means the actual copies of all or any portion of Allocate, including backups, updates, merged or partial copies permitted hereunder or subsequently provided to you. "Data" means the BOC's Summary Files 1-4 of the 2000 Census data provided with the Product. "Related Materials" means all of the printed materials, non-Data, and whatever is in the package, or accessed "online," via electronic documentation, or downloaded, or otherwise supplied by or from BOC or SRC for use with the Licensed Software. "License" means the grant of certain limited rights to use and maintain the Licensed Software, Data, Copies and Related Materials. Where used herein the term "You" or "you" shall refer to the Licensee. "Licensor" is the BOC, subject to the rights of SRC in the Licensed Software. The Licensed Software and all Related Materials are provided subject to the following terms and conditions.

2. LICENSE AND RESTRICTIONS. The Licensed Software is licensed, not sold. In order to preserve and protect its rights under applicable law, Licensor is not selling you ownership rights to the Licensed Software. The BOC specifically retains title to all Data owned by it and incorporated into the Licensed Software. SRC retains title to the Licensed Software, except for the portions licensed to SRC by third parties, title to which portions is retained by those third party owners.

Your License permits you to install the Licensed Software on the hard drive of your Computer,

or to store or install the Licensed Software on **one (1)** network server or similar storage device, and used **only** to access the Licensed Software on that server over an internal network. One backup copy may be made for each legally obtained media copy you have received, provided that all copyright notices and other information relating to intellectual property rights are maintained, and possession of the copy is retained by you in a secure location.
