(Alcohol and Drug CPMS)

The Holiday Season is approaching fast. So is the date that we will no longer accept old alcohol and drug CPMS forms. After December 31, 2007, we will no longer accept old alcohol and drug CPMS forms. Please destroy any unused, old A&D CPMS forms you may have.



We appreciate those of you that are using the new A&D forms. These are forms that have a Revision Date of "07/07" in the bottom right-hand corner. Clients who were enrolled on old A&D CPMS forms should be discharged on the old A&D CPMS forms, as they would have the client information from the enrollment form.

If you need more forms, please give Bonnie a call. She can send the forms out to you right away.

<u>Note</u>: There is no new form for the Mental Health CPMS. Continue using the forms with "01/05" in the bottom right hand corner.

Be sure to use the <u>right provider number</u> when enrolling your clients in treatment services. Many of you have more than one provider number. This is because you offer more than one service, i.e. outpatient and residential. If you have questions about your provider

numbers, please give any of us a call.

So you need some new forms or manuals?

If you need to order additional CPMS forms or CPMS manuals, give Bonnie Landers a call. When you call her, please have the following information ready:

- Type of form you need (i.e., Mental Health Basic, DUII Education, etc.)
- Form Number (this is located on the bottom right hand corner. Example: 0460)



- **Amount of forms needed** (for a six month period)
- Contact Info (Your Name, Provider Name, Phone Number and Address)

Remember, that when you enroll clients into regular outpatient services, the eligibility code is '00' for 'None'. If the client is being enrolled in your DUII Outpatient program, please use the

appropriate eligibility code (06 - DUII Diversion or 26 - DUII Convicted). Thank you for your attention to detail.
