New Feature on Addiction MMR?

Last month we announced that the Chemical Dependency Treatment MMR is going to be different in the near future.

This created a lot of concerns in our

CPMS community. It was not our intent to upset anyone but we did want your attention and we did manage to do just that.

The idea that there is going to be a trick performed and make all your clients disappear is not true. There will be a change and that is the asterisk "*" to indicate those chemical dependency clients that have been open longer than three years.

It will not be very soon however. At first the project has to be prioritized and the amount of work involved still needs to be established. It is not going to be a permanent feature. Our intention is to create the special Addictions Treatment Monthly Management Reports (MMR 24-233) annually or biannually.

We were pleased to receive all the termination information. And we hope that you continue to be willing to make the time to ensure the highest quality possible of the data that you send to us.

It's very important that our data systems have accurate information. We make many decisions, affecting Oregonians and CD Providers, based upon that information. If you have any questions or concerns, please give us a call.

Changes to Referral source(s) for A&D

July 1st 2007 we introduced a new box called: "recent arrest within the last 30 days" on the CPMS A&D form. This was because of a change in the Federal reporting requirements. We took the opportunity to make a few more changes to synchronise the Mental Health and Alcohol & Drug form. It involved Boxes 15 & 53 Referral Source(s) and Box 22 Living Arrangement.

The changes on Living arrangement were minor but the wording is now equal to the wording on the Mental Health form and the numbering sequence makes sense. The impact on Box 15/53 was a lot bigger and a lot of codes and descriptions have changed. If you did not attend one of our trainings this summer you might have missed the announcement
