FIRST RESPONDERS CERTIFICATION

First responders will need to file for certification with the EMS and Trauma Systems Program in August 2008. The EMS/TS Program has sent information to individuals and agencies that have reported providing first responder care. The EMS/TS Program has begun certifying first responders. NHTSA EMS Education Agenda for the Future

The National Highway Traffic Safety Administration (NHTSA) EMS Education Agenda for the Future outlines a five-part plan for reaching some of these goals. Included in this plan are:

- 1) Creation of a National Core Content;
- 2) Creation of a National Scope of Practice;
- Creation of National EMS Education Standards based on the Core Content and Scope of Practice;
- 4) Creation of National Certification;
- 5) National Accreditation of EMS Education program (primarily paramedic).

The first three documents are completed and directly impact Oregon because we refer to national standard curricula in our EMS rules. Like 45 states, Oregon uses the NREMT for EMT basic and paramedic, making this a de facto national certification. Finally, the NREMT has decided that by 2013, only graduates of nationally accredited programs can sit for the NREMT paramedic exam. As a note, the National Scope of Practice is considered a "floor" and no one expects every state to follow it exactly at every level.

During July, 15 new ambulances were licensed. Oregon Law Enforcement Data Systems background reviews were conducted on 194 new applicants and 28 national background reviews were completed.

Three complaint investigations were opened. One first responder surrendered his/her certificate pending the outcome of a criminal proceeding. Twenty-four certificate holders are completing court diversion requirements for DUII/BUII (boating under the influence). There are currently 18 certificate holders on department-stipulated probation.

Trauma administrative rules revision meetings

On Aug. 19 an open meeting for trauma providers will be held from 9:30 a.m. to 3 p.m. to discuss the trauma administrative rules revision, focusing on elements for the Level 5 category in Exhibit 4, and Exhibits 1, 2, 3 and 5 and the administrative rules. We welcome two very capable individuals to the EMS and Trauma Systems Program staff:


