
Creating AV Fistulas in All Eligible Hemodialysis Patients

Web-based Training Courses





Acute Hospital Inpatient Prospective Payment System (IPPS)

This web-based training course provides an overview of the Acute Hospital Inpatient Prospective Payment System (IPPS). It includes a basic explanation of inpatient hospital coverage, billing and payment under the prospective payment system. (July 2008)

CMS Form 1500

This web-based training course provides information that will allow you to file Medicare Part B claims accurately and reduce your chances of receiving unprocessable rejections. (May 2007)

Certificate of Medical Necessity

This web-based training course contains information about the Certificate of Medical Necessity, commonly known as CMN. This course will be helpful to physicians, health care professionals, and medical administrative staff in completion, submission, and maintenance of the documentation required to verify the CMN. (July 2007)

Diagnosis Coding: Using the ICD-9-CM

This web-based training course teaches you how to select accurate diagnosis codes from the ICD-9-CM volumes and how to use diagnosis codes correctly on Medicare claim forms. (October 2007)

Front Office Medicare

This web-based training course provides essential knowledge needed for "checking in" Medicare patients. (January 2008)

HIPAA

This web-based training course provides the learner with a general understanding of the history and purpose of the Health Insurance Portability and Accountability Act. (March 2004)

Medicare Fraud and Abuse

This web-based training course will teach you to identify Medicare fraud and abuse. You will also learn what safeguards to use to protect yourself against fraud and abuse and what liability and penalties you could face if you commit fraud or abuse. (April 2007)

Medicare Preventive Services: Part 1 Adult Immunizations

This web-based training course provides information about Medicare's coverage for influenza, pneumococcal, and hepatitis B vaccines. (September 2007)

Medicare Preventive Services: Part 2 Women's Health

This web-based training course provides information about Medicare's coverage for mammography services, pap tests, pelvic exams, colorectal cancer screenings, and bone mass measurements. (October 2007)

Medicare Preventive Services: Part 3 Expanded Benefits

This web-based training course provides information about Medicare's coverage for the three new services added to the Medicare program in 2005, as a result of the Medicare Modernization Act of 2003; initial preventive physical exam (a.k.a. "Welcome to Medicare" physical exam), diabetes and cardiovascular disease screenings. The course also includes information on diabetes self management training, medical nutrition therapy and other diabetes supplies, colorectal, prostate, and glaucoma screenings and bone mass measurements. (November 2007)

Outpatient Code Editor (OCE)

This web-based training is useful for physicians and other health care professionals. This course addresses the OCE in the Fiscal Intermediary Standard System. (April 2008)

Skilled Nursing Facility Consolidated Billing

This web-based training course contains information about Skilled Nursing Facility Consolidated Billing "under arrangement" agreements between Skilled Nursing Facilities and other providers or suppliers. (October 2007)

Understanding the Remittance Advice for Institutional Providers

This web-based training course is designed to provide institutional provides and their billing staff with general remittance advice (RA) information. This course provides instructions to help you interpret the RA received from Medicare and reconcile it against submitted claims. It will give guidance on how to read Electronic Remittance Advices (ERAs) and Standard Paper Remittance Advices (SPRs), as well as information regarding balancing and RA. The course also provides and overview of software that Medicare provides free to providers for viewing ERAs. (August 2006)

Understanding the Remittance Advice for Professional Providers

This web-based training course is designed to provide professional providers and their billing staff with general remittance advice (RA) information. This course provides instructions to help you interpret the RA received from Medicare and reconcile it against submitted claims. It will give guidance on how to read Electronic Remittance Advices (ERAs) and Standard Paper Remittance Advices (SPRs). The course also provides an overview of software that Medicare provides free to providers for viewing ERAs. (December 2006)

Uniform Billing (UB)-04


This web-based training course addresses hard copy and electronic billing requirements for Medicare institutional provider (i.e., hospitals, skilled nursing facilities, end stage renal disease providers, home health agencies, hospices, and outpatient rehabilitation clinics, etc). (July 2008)

World of Medicare

You will learn about its purpose and history, the types of Medicare coverage, the roles agencies and contractors play, and the claims handling process. You will also learn about beneficiary related topics such as eligibility and benefit options. (September 2007)

National Provider Identifier Fact Sheets

The National Provider Identifier General Information

The Health Insurance Portability and Accountability Act (HIPAA) of 1996 requires the adoption of a standard unique identifier for health care providers. The NPI Final Rule issued January 23, 2004 adopted the NPI as this standard. Read more about NPI in this fact sheet. (January 2006)

Covered organization health care providers are responsible for determining if they have subparts that need NPIs. If there are subparts that need NPIs, the covered health care providers must ensure that the subparts obtain their own NPIs, or must obtain them for the subparts. National Provider Identifier Training Package

CMS has developed a Training package for NPI that will assist providers with self-education, as well as education of staff. This package is also useful to national and local medical societies for group presentations and training. The entire package will consist of five modules: General Information, Electronic File Interchange (EFI), Subparts, Data Dissemination and Medicare Implementation. Each Module consists of a PowerPoint presentation (with speaker's notes) and is designed to stand alone or can be combined with other Modules for a training session tailored to the particular audience.

Module 1: General Information

Audience - All Health Care Providers

Description - Provides a basic overview of the National Provider Identifier (NPI)

Module 2: Electronic File Interchange (EFI)

Audience - All Health Care Providers and organizations interested in becoming EFI Organizations *Description* - Provides details on the EFI process and information for EFIOs

Module 3: Subparts

Audience - All Health Care Providers *Description* - Provides details on the EFI process and information for EFIOs

Module 4: Data Dissemination

Audience - All Health Care Providers

Description - describes the policy by which CMS will make certain NPPES data available as well as the data CMS will be disclosing

Module 5: Medicare Implementation

Audience - All Medicare providers

Description - Provides the NPI requirements specific to Medicare providers. This module will be updated as new requirements are announced or changes are made.

Physician Quality Reporting Initiative (PQRI) Tool Kit

2008 PORI Coding for Quality Handbook

Description – A handbook that delineates coding and reporting principles and provides implementation guidelines for how to successfully report measures.

2008 PQRI Data Collection Worksheets

Description – Measure-specific worksheets that walk the user step-by-step through reporting for each measure. These worksheets may be used by the practice on a concurrent basis to collect PQRI data.
