
Re: Whirling Disease Initiative

Dear Mr. Little:

I am sorry to say that the Whirling Disease Steering Committee has decided not to request a full proposal from you for 2004-2005 research funding on filtration efficacy for whirling disease TAM removal. All of the membrane filtration techniques suggested for testing (with nominal pore sizes ranging from 0.08- 5 microns) would easily collect TAMs following exhaustive pre-filtration; thus there appears to be no reason to conduct such assays.
