

### **Forest Announces Special Forest Product Changes**

The Mt. Hood National Forest announces changes in special forest product removal permits to take effect this spring. Mushroom harvesters must now have a permit for personal use gathering. Firewood load tickets have changed from 1/3 cord per ticket to 1/2 cord per ticket. The maximum amount allowed per household per year will now be 5 cords.


A permit is now required to harvest mushrooms for personal use. The permits will be free, and self-issuing. Permits will be available at Ranger Stations and the Mt Hood Information Center as well as on line at <a href="https://www.fs.fed.us/r6/mthood">www.fs.fed.us/r6/mthood</a>. To get your permit on line, go to the web page, click on Special Forest Products, go to the mushroom section and follow directions from there. You can print the actual permit, fill it out, sign it, and keep it with you when you're harvesting mushrooms.

Firewood season this spring will begin as soon as the snow melts and weather permits. Personal use Firewood permits sell for \$10.00 per cord. In years past, you were allowed up to three trips to get a cord of wood out of the forest. Starting this spring, you will now have to remove your cord of wood in two trips. The limit per household per year has gone from 8 cords to a 5 cord maximum. The reason for this is declining availability.

All special forest products are being reviewed and appraised using current market value prices. This may increase or decrease the current rates being charged this spring. These price changes are being made as the result of National Direction.

project will be off-forest, from
the City of Dufur water intake

upstream to the Forest boundary, within the Fifteenmile Creek Watershed. Fifteenmile Creek is a Tier I watershed, as defined by the Northwest Forest Plan. Fifteenmile Creek is also the water source for the City of Dufur. Project description includes instream channel and flood plain restoration, riparian planting, road work, piping the Orchard Ridge Ditch (formally known as Lydia's Ditch). Post monitoring will occur. Implementation will occur in 2003. Multiple agencies will be involved: Oregon Department of Fish and Wildlife, Natural Resource Conservation Soil District, Oregon Department of Forestry, City of Dufur, as well as adjacent land owners.

The Mt. Hood National Forest is beginning an analysis of its mainline road system to determine the economic, environmental and social effects of the system. The analysis and an accompanying roads atlas will be available for public review on January 13, 2003.

The scope of the analysis will focus on approximately 650 miles of passenger car roads and heavily used high clearance roads. The Forest-wide Roads Analysis is not a decision document. Any changes in the management of the road system will be based upon site-specific analysis conducted in subsequent environmental assessments at the watershed or project level.

#### Rockfall Protection Project on Hwy 26

M.P.49.1—between Kiwanis Camp turnoff and the runaway truck ramp on Hwy 26. Construction begins mid to late July 2001, this will be a two-year project. Work will be shut down during the winter due to nesting issues (owl).

The rock cliff will be blasted to remove loose material, and the highway will be realigned further away from the cliff.

• 2002—Intermittent lane closures of all lanes for paving, Monday through Thursday.

#### Hood River Canyons Rockfall Project

Mt. Hood Highway US 26safety is a concern for both motorists passing through and for the people who live and conduct business in the mountain communities and recreational areas. Plans are underway to develop a \$3 million project to improve safety along a rockfallprone area of Oregon Hwy 35 Hood River Highwaynear Milepoint 72. This area is also known as the "S" curves. Chronic rockfall in this area presents a safety hazard for motorists.

The project involves removing unstable rock outcroppings, bolting rocks into place, installation of a rock catchment fence and placement of new concrete barrier.

The project is planned for bid letting in summer 2002, with construction beginning that fall.

During a tentative Monday through Thursday construction schedule, motorists can expect traffic to be controlled by flaggers as the roadway is reduced to one lane. Traffic will not be restricted from noon on Friday to midnight on Sunday.

Timberline Road —
 Timberline Lodge to the Hwy 26 Junction
 Goes to bid in February

Goes to bid in February 2002, construction begins in the summer of 2002.

This is a preservation project. Timberline Road will be ground to an even layer and inlaid with two inches of asphalt. There will be intermittent lane closures with flaggers and cones. Motorists can expect 10-15 minute delays.

 Zigzag to Rhododendron, Phase 1—Hwy 26 from Lolo Pass Road to Road 9 Goes to bid in July 2002, construction begins in the fall of 2002.

This modernization project will widen the highway to four lanes with turn pockets, replace the culvert at Bear Creek with a 16' long bridge, and alter some accesses to the highway. One lane of traffic in each direction will be maintained throughout the project.

 Zigzag to Rhododendron, Phase 2—Hwy 26 from Road 9 to Rhododendron

Goes to bid in July 2003, construction begins in the fall of 2003. This modernization project will widen the highway to four lanes with turn pockets. A major aspect of this project will be the replacement of the Zigzag River Bridge with a new 68' wide bridge. One lane of traffic in each direction will be maintained throughout the project.

## Palmer Quarry Environmental Impact Statement

ODOT and the USFS will research and develop an environmental impact statement to examine the continued use of the site as a rock quarry. No impact to motorists.

 Mineral Creek Culvert— Highway 35, just south of White River

Bid in the summer of 2003, construction begins in the autumn of 2003.

During the White River flood in October 2000, the White River overflowed its channel and partially flowed into the Mineral Creek channel. This project will construct a new eight-foot diameter culvert next to the existing four foot culvert to help avoid a catastrophic failure of Highway 35. Shoulder closures only, minimal impact to traffic.

#### Juncrock Planning Area

In response to comments received from the scoping letter the District will be writing an EIS for Juncrock. The ID team is formulating additional alternatives in response to comments received during scoping. One alternative will focus on meeting silvicultural needs of the stands, while meeting Forest Plan Standards and Guides for other resources. Another possible alternative would contain an upper diameter limit on trees in stands to be treated. The draft EIS is scheduled for completion by the end of May.

#### Douglas Cabin Planning Area

The design team was out in the field all last fall, identifying stands in need of treatment. The early design work for the proposed action may be completed this spring. There is discussion on whether or not this planning area will be completed at this time. This planning project may be put on hold until the Stroud and Mill Creek Buttes Planning areas are completed.

#### Mill Creek Buttes has been added to the Stroud Planning Area

Recon on the Stroud and Mill Creek Planning Areas will begin during the spring of 2002. Planning both areas will enable the district to better utilize fuels reduction dollars. Stroud Planning Area and Mill Creek Buttes are located in The Dalles City Watershed. They are included in the Surveyors Ridge LSR. The Surveyors Ridge LSR Plan was signed in 1997. These planning areas have high tree mortality due to stress and insects. Mortality has been occurring for 20 years or longer, resulting in high natural fuel loads. Stroud and Mill Creek Buttes will focus on identifying and treating stands with a high natural fuel load and restoring forest health. Stands will be better protected from a stand replacing fire if the existing fuel load is reduced.

## Kenable Spring Trail Reconstruction

The existing trail is open to horses, mountain bikes, and hikers. Relocation will minimize trail maintenance and provide a better recreation experience. The crossings will be constructed on the existing trail. One will be a two stringer decked bridge and the other will consist of cobble placed in the streambed itself. Both of these stream crossings will reduce the amount of sedimentation into Fivemile Creek.

Hood Snowmobile Club for an area 1 acre in size to construct a 32'x60' storage building. This old landing is approximately 100 yards east of Skyline Snopark. The building will be constructed of wood with a poured cement floor and brown steel roof. The building will house a snow cat, trail groomer, and a 2000 gallon diesel storage tank. A 6-foot high chain link security fence may also be erected around the building if additional security is needed. The Mt. Hood Snowmobile Club will be responsible for all maintenance.

continuing. The Barlow Ranger
District is proposing to burn
approximately 2,200 acres in
two different areas during the
fall of 2001 and spring of 2002.
The objective is to introduce fire

back into the ecosystem, reduce the natural accumulation of litter, prevent the ark buildup around the base of large ponderosa pine, and enhance the fire dependent native grasses. forbs, and shrub species. Underburning will enhance deer and elk forage quantity and quality, reduce risk of a stand replacing fire, and protect large ponderosa trees from the effects of future underburning. Required surveys for these projects have been completed. Final field verifications are being completed.

The proposed action includes treating forest vegetation, constructing temporary roads, reconstructing roads, and closing roads within the planning area. In particular, thinning approximately 564 acres of dense, second growth timber stands. Overmature stands, especially those heavily infected with Indian Paint Fungus (Echinodontium tinctorium), are proposed to be regenerated on approximately 217 acres, some of which are within the Highway 26 corridor to help meet visual quality objectives for the long term. Commercial thinning and restoration projects of approximately 19 acres, within the riparian reserve area of Frog Creek and it's tributaries, are also proposed. Overstory

removal of non-native ponderosa pine in an artificially regenerated plantation is proposed on approximately 21 acres. Temporary road construction of approximately 4.3 miles, road reconstruction of approximately 3.2 miles, and road closure and decommissioning of approximately 7.2 miles of roads are also proposed activities. A draft EIS is planned to be filed with the **Environmental Protection** Agency (EPA) and available for public review by Spring/Summer.

The Zigzag Ranger District is planning approximately 3,000 acres of timber stand improvement projects for the next 5 years in managed plantations ranging from 10-25 years of age. Precommercial thinning promotes tree species diversity, growth, wood quality and forest health. It reduces the susceptibility to insect and disease attacks and enhances wildlife habitat. This project is planned throughout the district but primarily in the Timothy Lake and High Rocks area. Other areas will be Trillium Lake, Wildcat and Lolo Pass. We anticipate a decision in the summer of 2003.

Contact: Marty Stein Phone: 503-668-1764 Email: mstein@fs.fed.us The Bonneville Power Administration (BPA) is proposing to remove unwanted vegetation from within its transmission line right-of-way and tower structures. The proposed project area includes 295 acres along 5.5 miles of right-of-way from Lolo Pass west to the Forest boundary. The goal is to remove tall growing vegetation that is currently, or will soon be, a hazard to continued electrical transmission. The resulting vegetative community would consist of low growing shrubs and herbs. Unwanted vegetation would be removed with a combination of manual, mechanical and chemical means. Any herbicide use would be ground based and applied only to the target plant. Treatments would be designed to provide for a 3 to 8 year maintenance-free period. In addition, four noxious weed species occur within the transmission right-of-way. To control and eventually eradicate weed populations, it is proposed that herbicide would be applied to individual weed plants, leaving desirable plant species. Treatments for noxious weeds would be conducted annually.

These trees have been identified with metal tags near their bases. A letter will be coming from the Zigzag Ranger District reminding homeowners of their responsibility to keep their lots reasonably hazard free. Information on permittee responsibilities and treatment of hazardous trees will be shared with permittees at the Mt. Hood Forest Homeowners Annual Meeting April 30, 2002 in Portland. There will also be a public information workshop in the Zigzag/Welches area in June at a location and date still to be determined.
