Analytes to measure (in appropriate biological fluid): Armodafinil in plasma.

Waiver request of in-vivo testing: 50 mg and 150 mg, based on acceptable (i) bioequivalence studies on the 250 mg strength, and (ii) proportional similarity of the formulations and (iii) acceptable in vitro dissolution testing of all strengths.
