Active ingredient: Diflunisal

Form/Route: Tablets/Oral

Recommended studies: 1 study

Type of study: Fasting

Design: Single-dose, two-way, crossover in-vivo

Strength: 500 mg

Subjects: Normal healthy males and females, general population

Additional Comments: Subjects should not have a history of cardiovascular and gastrointestinal disease, allergy to aspirin or other anti-inflammatory drugs.

Analytes to measure: Diflunisal in plasma

Bioequivalence based on (90% CI): Diflunisal

Waiver request of in-vivo testing: 250 mg based on (i) acceptable bioequivalence studies on the 500 mg strength, (ii) acceptable dissolution testing across all strengths, and (iii) proportional similarity in the formulations across all strengths.
