# CHARTER ENVIRONMENTAL, INC. WINS SBA AWARD



Robert Delhome

Robert Delhome, president of Wilmington, Massachusetts-based Charter Environmental, Inc. started his business in 1997 with 2 employees and \$300 in seed capital. Eleven years later, Delhome is the 2008 U.S. Small Business Administration's Massachusetts Small Business Person of the year.

Delhome worked for environmental contractors for several years before deciding to branch out on his own. Charter Environmental is a civil and environmental contractor that specializes in servicing the needs of consultants/engineers, contractors, private sector clients and government agencies.

Born in Panama, Delhome was able to utilize the SBA's 8(a) Business Development Program, intended to help socially and economically disadvantaged businesses compete in the federal procurement marketplace. The 8 (a) program helped give Delhome's company the boost it needed to be successful in this competitive field.

From Charter's modest beginning as a two employee shop in the spare bedroom of his home, Robert Delhome has grown his business into a \$30 million a year operation with over 100 employees.

# ECONOMIC STIMULUS BENEFITS FOR YOUR BUSINESS

The Economic Stimulus Act of 2008 contains two provisions that provide tax benefits for businesses. The first provision increases the limit up to which a business can expense property purchased and placed in service during its 2008 tax year. The second



provision provides an additional 50 percent special depreciation allowance for property acquired and placed in service during calendar year 2008.

Unlike the economic stimulus payments that millions of individuals have already received, the tax benefits for businesses are not automatic; businesses must act to take advantage of the new provisions by purchasing qualifying property.

SBA has created and online tax savings resource center to help small businesses understand these benefits. The center located at www.sba.gov/stimulus contains three resources:

- 1. Fact Sheet The fact sheet provides a clear explanation of the small business tax benefits.
- 2. **Depreciation Calculator** This useful tool provides an estimate of the first-year depreciation available under the provisions.
- Online Seminar This brief tutorial summarizes the tax benefits and concludes with the depreciation calculator.

These resources should help small businesses take advantage of the stimulus package. However, because there are exceptions and additional requirements, small businesses are encouraged to contact their tax advisor to determine exactly how the provisions and implementing tax code of the 2008 economic stimulus package apply to their business.
