DRAFT MINUTES

Summary of Board of Directors Personnel Committee Meeting 9:00 a.m., Wednesday, September 4, 2002

1. Call to Order – Roll Call: 9:06 a.m.

Present: Dena Mossar, Chair; Harold Brown, Scott Haggerty (9:30 a.m.), Jerry

Hill, Nate Miley (9:30 a.m.), Julia Miller (9:12 a.m.), Shelia Young.

Also Present: Randy Attaway.

Absent: Liz Kniss.

- **2. Public Comment Period:** There were none.
- **3. Approval of Minutes of April 26, 2002:** Mr. Brown moved approval of the minutes; seconded by Ms. Young; carried unanimously by acclamation.
- 4. Proposed Amendments to District Administrative Code Division III, Section 13: Method of Filling Vacancies: The Committee considered amending the Administrative Code Division III; Section 13: Method of Filling Vacancies to streamline the hiring process.

Peter Rogosin, Acting Human Resources Officer, presented the report stating the proposed amendments simplify the process for filling vacancies and address issues that have come up when having to deal with this section of the Administrative Code. The amendments provide a uniform set of principles governing employee selection procedures that are consistent with applicable professional standards.

During discussion, it was noted that Section 13.1(e) referred to a "partial listing of reasons for which an applicant or candidate for employment may be rejected". It was suggested that the language be revised to indicate that the list was a comprehensive "but not limiting" list of reasons. There was also discussion on the ability for electronic filing of an application under Section 13.1(d). Bill Norton, Interim CEO, stated the District is working on a new web site that will be fully operational by the end of the fiscal year and recommended this issue be addressed at that time.

Committee Action: Mr. Hill moved recommendation to the Board to approve the proposed amendments to the District's Administrative Code Division III, Section 13: Method of Filling

Vacancies, including the additional language under Section 13.1 (e) as discussed; seconded by Ms. Young; carried unanimously by acclamation.

5. Closed Session – Conference with District's Labor Negotiator, IEDA: Pursuant to Government Code Section 54957.6(a) the Committee met with the District's Labor Negotiator to discuss compensation for unrepresented personnel in the Management and Confidential classes.

The Committee convened to Closed Session at 9:16 a.m. The Committee Reconvened to Open Session at 9:34 a.m.

Brian Bunger, Acting Legal Counsel, reported the Committee met in Closed Session with a representative from IEDA to discuss Management and Confidential compensation; the Committee provided guidance to IEDA to move forward with discussions.

Re: Conduct Interviews of Candidates to Fill the Alternate Medical

Profession Position on the District Hearing Board

RECOMMENDED ACTION:

The Personnel Committee will interview and consider candidates to fill the alternate Medical Profession position on the District Hearing Board. The Committee will then make a recommendation on candidate selection for consideration by the Board of Directors.

BACKGROUND:

Pursuant to Section 40800 of the California Health and Safety Code the District is required to maintain a Hearing Board consisting of five members. Further, section 40801 requires that one of the Hearing Board members is from the medical profession and has specialized skills, training or interests in the fields of environmental medicine, community medicine, or occupational/toxicological medicine. Section 40800 allows the District to appoint one alternate for each member of the Hearing Board with the same qualifications specified in Section 40801.

DISCUSSION

Interview Time:

The Hearing Board currently has a vacancy for the alternate medical professional member.
