Chairperson Haggerty announced the March 17, 2004 Board meeting is cancelled.

Commendations/Proclamations: Chairperson Haggerty acknowledged Director Dena Mossar who has served on the Board of Directors since March 1999. Chairperson Haggerty directed staff to send Director Mossar her plaque along with a letter of appreciation. Chairperson Haggerty also directed staff to send a letter to Deputy Director Maria Ayerdi, who resigned from the Board in January.

#### **PRESENTATION**

8. Summary of Environmental Community Tour

Staff provided a summary of the Environmental Community tour and the Air District's response to questions raised during the tour.

Jack Broadbent, Executive Officer/APCO, presented a report of the February 18, 2004 Environmental Community Tour of Oakland. Mr. Broadbent reviewed the community member comments and concerns raised during the tour and summarized how the Air District is addressing these concerns.

#### **Other Business**

- 10. Chairperson's Report

Chairperson Haggerty discussed the Association of Bay Area Governments (ABAG) and the Metropolitan Transportation Commission (MTC) putting together a joint planning council that will look at comprehensive regional planning for the nine Bay Area counties. Mr. Haggerty stated that a comprehensive plan should not only include transportation and housing, but air quality.

Director DeSaulnier congratulated Chairperson Haggerty on his re-election. Director DeSaulnier added that at the last Regional Agency Coordinating Committee (RACC) having the Air District a part of any kind of regional transportation/land-use commission was discussed. Director DeSaulnier noted that the ultimate goal is to have better coordination between the regional agencies and coordination on land use issues; and that it is appropriate for the Air District to be include in these discussions. Director DeSaulnier stated that since the RACC is already established and designated on the implementation of the regional agency's Smart Growth Implementation Plan, it would be appropriate to continue with the RACC.

Chairperson Haggerty directed staff to send a letter to Senator Torlakson and the Chairs of MTC and ABAG. The letter should discuss the fact that, if there is going to be a comprehensive regional plan, the Air District believes it should be at the table; that the Air District would prefer that this move to the RACC; and if that is not possible; then the Air District would want an equivalent amount of seats as ABAG and MTC as the new joint planning council is established. Mr. Broadbent will sign the letter to ABAG and Chairperson Haggerty will sign the letter to MTC.

#### COMMITTEE REPORTS AND RECOMMENDATIONS

6. Report of the Budget & Finance Committee Meeting of February 25, 2004

Director Daly presented the report and stated that the Committee, lacking a quorum, met on Wednesday, February 25, 2004. Staff reported on the impact of the Governor's proposed budget for fiscal year 2004/05 on the Air District. Staff reviewed the timeline for the State budget and noted that the Legislature hoped to pass the budget by July 1<sup>st</sup>. The District's share of subvention this year is \$1.8 million, which is the same as last year. Staff reported that the Governor's proposal would shift \$1.3 billion in property taxes from local governments to the State. The Governor's proposal does not specify if the Air District is included in this shift, and if the District is included, how much property tax would be taken. Staff also reviewed the State revenues and expenditures for the 2004/05 fiscal year.

Staff presented the Second Quarter Financial Report for Fiscal Year 2003/2004. Staff reviewed the Statement of Revenue and Statement of Expenditures and the comparison of budget to actual for each. Staff reviewed the income and expenditures of the Transportation Fund for Clean Air (TFCA) fund.

Staff presented a report on the Lawn Mower Buyback Programs and a request for the transfer of \$135,000 from the Reserve for Contingencies to continue the programs in 2004. Staff noted that seven counties (Alameda, Contra Costa, Solano, Sonoma, Napa, San Mateo and San Francisco) and the City of Sunnyvale want to partner with the Air District to sponsor local lawn mower buy-back programs. Staff is also working with Alameda County to coordinate another lawn mower buy-back program in that county again this year. The consensus of the Committee was to forward this request to the full Board for approval.

The March 24<sup>th</sup> meeting of the Committee has been cancelled. The next meeting of the Committee is scheduled for 9:45 a.m., Wednesday, April 28, 2004.

**Board Action:** Director Daly moved the Board approve the report of the Budget and Finance Committee; seconded by Director Torliatt; carried unanimously without objection.

7. Report of the Mobile Source Committee Meeting of February 26, 2004

The Committee met on Thursday, February 26, 2004 and staff presented reports on the following five items and the Committee recommends the Board approve the actions under each item:

- 1) Carl Moyer Program Grant Allocations.
  - Approval of \$3.32 million in grants to 16 projects.
  - Approval of \$500,000 in future Carl Moyer Program funds for a specified project at the Port of Oakland.
  - Authorize the Executive Officer to offer grants to additional projects as more Carl Moyer funds become available during the 2004 calendar year.
  - Authorize the Executive Officer to solicit additional projects that would assist
    the Air District in complying with the requirements of Health & Safety Code
    Section 43023.5 when distributing additional Carl Moyer funds that become
    available during the 2004 calendar year.

- Authorization for the Executive Officer to enter into funding agreements with recipients of Carl Moyer grants.
- 2) An amendment to the San Francisco County Program Manager expenditure program for fiscal year 2003/2004.
  - Approve the allocation of \$216,000 in TFCA Program Manager funds for 375 Cleaire Longview system devices for 375 San Francisco Municipal Railway (MUNI) coaches.
- 3) The allocation of the remaining available fiscal year 2003/2004 Transportation Fund for Clean Air (TFCA) Regional Funds for two projects.
  - Approve \$1 million in TFCA Regional Funds to the Lower Emission School Bus Program.
  - Approve \$512,000 in TFCA Regional Funds to the Metropolitan Transportation Commission (MTC) to help install particulate matter (PM) and nitrogen oxide (NOx) filters on transit buses throughout the region.
- 4) An amendment to the Marin County Program Manager expenditure program for fiscal year 2003/2004.
  - Approve the allocation of \$98,675 in Marin County Program Manager funds for the County of Marin's Ride and Roll Program.
- 5) An amendment to the Alameda County Program Manager expenditure program for fiscal year 2003/2004.
  - Approve the allocation of \$941,130 in Alameda County Program Manager funds, awarding:
    - \$500,000 to Alameda County Transit (AC Transit) for the Transit Bus Priority System, International Boulevard project;
    - \$231,200 to the Alameda County Congestion Management Agency for the Guaranteed Ride Home project;
    - \$125,996 to the City of Berkeley for the City Carshare, East Bay Expansion project; and
    - \$83,934 to the Livermore Amador Valley Transit Authority (LAVTA), Altamont Commuter Express (ACE) Shuttle Service, Pleasanton ACE Station to Bay Area Rapid Transit (BART) project.

The Committee also directed staff to make some changes to various reports. The March 11, 2004 meeting of the Committee has been cancelled. The next meeting of the Committee is scheduled for 9:30 a.m., Thursday, April 8, 2004.

**Board Action:** Director Young moved Board approval of the report as written and Board approval of the five action items as stated in the report; seconded by Director Torliatt.

In response to a question from Director Miley, Mr. Broadbent stated that he has met with members of the Pacific Institute about the community being involved with the process with the Moyer funds, but noted that the current Moyer funds are very restrictive on how the money is spent. Mr. Broadbent added that the Air District will continue to meet with the

Pacific Institute and take into consideration their concerns as the District works with the Port of Oakland to dispense the money.

## ADMINISTRATIVE SERVICES DIVISION - W. TANAKA, DIRECTOR

The Second Quarter Financial Report was presented to the Budget & Finance Committee at the February 25, 2004 meeting. Also presented at the meeting was the Governors proposed budget for Fiscal Year 2004/2005. A request, not to exceed \$135,000, to fund the 2004 Lawn Mower Buyback Program was presented to the Committee.

**AGENDA: 4** 

Staff, with budget responsibilities, has been busy gathering and entering preliminary budget data for the FY 2004/2005 budget. Staff is faced with the challenge of preparing a balanced budget that will have little or no growth. With the possibility of a cut in property tax revenue, the budget preparation will proceed with uncertainty as a final decision is weeks away. An alternative plan has been developed should the District lose revenue from property taxes. This plan will be presented to the Budget & Finance Committee for approval and recommendation to the full Board.

## COMPLIANCE & ENFORCEMENT DIVISION - K. WEE, DIRECTOR

District staff met with City of Milpitas staff and Milpitas odor stakeholders on February 5, to distribute a Memorandum of Understanding amongst the District, the City of Milpitas, and odor stakeholders. The MOU outlines a Rapid Notification Program for Milpitas where complaint information is emailed to the odor stakeholder so proactive measures can be taken to reduce odorous emissions. All six Milpitas odor stakeholders are participating.

Staff gave a presentation on the Gasoline Vapor Recovery program at the 6<sup>th</sup> Annual CUPA Conference in Santa Clara on February 5. Staff attended the California Bus Association's 10<sup>th</sup> Annual Spring Maintenance Seminar on February 24 in San Jose to answer questions about Regulation 8, Rule 45. Compliance and Enforcement Division staff met with Engineering staff and a representative from a firm that does the majority of Ethylene Oxide (ETO) sterilizer source testing in the Bay Area to discuss permit conditions that monitor temperature of ETO catalysts.

Staff conducted training for the Public Information staff, and other interested staff, on how to use the over-the-phone foreign language translation service. Staff will conduct additional training of other Divisions on request. Revised Compliance Policy and Procedures Guidelines for Complaints and Regulation 5 - Open Burning were posted to the District website. New Guidelines for Asbestos Air Toxic Control Measure (ATCM) for Construction, Grading, Quarrying and Surface Mining Operations, were also posted. These documents help guide both industry and inspection staff on compliance with District Regulations. A Compliance Assistance Advisory was sent out to operators of vapor solvent cleaners who use halogenated solvents that are regulated by the US EPA. Staff responded to the Tesoro Refinery flaring incident of February 20 when a power loss resulted in significant flaring.

## **ENGINEERING DIVISION – B. BATEMAN, DIRECTOR**

## **Permit Evaluation Activity**

Major Permit Activity

The District issued a permit (#8799) to Tesoro Refining Company for a new knockout drum to control emissions from desalter pressure safety valves (PSV). Installation of this control system was required because on July 31, 2003, the desalter had the second PSV release in five years, triggering the requirement in Regulation 8-28 to vent PSVs to a control system.

The first revisions of the Refinery Title V permits were released for public comment. These draft revised permits address flare monitoring, compliance with refinery NOx caps, and miscellaneous critical issues identified by the refineries and EPA.

Mirant Potrero's proposed Alternative Compliance Plan (ACP) was approved. This plan allows the facility to use Interchangeable Emission Reduction Credits (IERCs), which are extra emission reductions achieved by the facility in the recent past, as offsets. These offsets may only be used to allow the facility to continue emitting at current levels, in spite of newly effective requirements that affect the source, a power plant in San Francisco.

Two new Title V permits were issued (Republic Services Vasco Road, Livermore, and International Disposal Corporation, Milpitas). One new Title V permit was released for public comment (San Francisco Airport, San Mateo)

#### **Toxics Program**

Health risk screening assessments were conducted for 31 permit applications, primarily diesel emergency generators. Rule development activities continued on Regulation 2, Rule 5, New Source Review of Toxic Air Contaminants. This rule development project had been delayed,

however, due to delays in the release of health risk assessment software tools by CAL/EPA, and presentation for adoption to the District's Board of Directors is not expected until the second half of 2004. Staff met with representatives of several community groups and the Advisory Council concerning the Rule 2-5. Staff completed quality assurance review of the 2002 toxic emission inventory; the annual toxic report is expected to be completed soon and available on the District's website.

#### INFORMATION SYSTEMS DIVISION – J. McKAY, DIRECTOR

## **Enterprise Resource Planning (ERP) Project for Air District Financial Systems**

JDE Budgeting is in use. The Administration Mitchell Humphrey cutover will occur at the beginning of the new fiscal year.

Administration and Human Resources continue to focus on modeling of business processes. Modeling Design for HR and Payroll involves significant innovation because these systems are currently paper based. Significant progress has been made, and HR may be able to go live before the July 1 scheduled date.

The first phase of implementation will not only replace the old Mitchell Humphrey's financial system, but will also absorb a small portion of the function currently in the IRIS/Databank system. The interfaces between JDE and the Districts' Engineering/Production systems (IRIS/Databank) have shown initial successful trials. Determination of appropriate tool sets and functional design for the Districts' future Engineering/Production Systems (used by Permits, Enforcement and Legal) continues as a separate, but linked, process.

## **Toolsets for Permits/Enforcement/Legal**

High-level functional design and toolset evaluations are ongoing with Engineering. The process of determining high-level system architecture will continue concurrent with the ERP implementation. This process will further mature in the first half of the calendar year, and will then receive full staffing as the ERP implementation completes.

#### **Web Site Development**

The roadmap for the next phase of the new site is under development. Infrastructure Development for web based query capability has initiated, with first results scheduled for release in May.

## LEGAL DIVISION – B. BUNGER, DISTRICT COUNSEL

The District Counsel's Office received 159 Violations reflected in Notices of Violation ("NOVs") for processing.

Mutual Settlement Program staff initiated settlement discussions regarding civil penalties for 54 Violations reflected in NOVs. In addition, Mutual Settlement Program staff sent 39 Final 30 Day Letters regarding civil penalties for 53 Violations reflected in NOVs. Finally, settlement negotiations by Mutual Settlement Program staff resulted in collection of \$46,967 in civil penalties for 90 Violations reflected in NOVs.

Counsel in the District Counsel's Office initiated settlement discussions regarding civil penalties for 91 Violations reflected in NOVs. Settlement negotiations by counsel in the District Counsel's Office and by counsel in the Contra Costa County District Attorney's Office resulted in collection of \$308,275 in civil penalties for 128 Violations.

#### PLANNING DIVISION – J. ROGGENKAMP, DIRECTOR

The Board approved allocation of \$3.3 million in Carl Moyer Program funds to 16 projects; allocation of available FY 2003/04 Transportation Fund for Clean Air (TFCA) Regional Funds to two projects; and amendments to the San Francisco, Marin, and Alameda TFCA County Program Manager expenditure programs for FY 2003/04. The District signed new agreements with the current vehicle buy-back contractors. The contractors purchased 157 vehicles in February 2004.

The Technical Committee and the Air Quality Planning Committee of the Advisory Council discussed preliminary evaluations of ozone control measures with staff, focusing particularly on measures contained in the San Joaquin Valley Unified APCD and South Coast AQMD plans. Staff met with ARB managers regarding progress on Further Study Measures in the 2001 Ozone Plan. Staff participated in conference calls comparing rules between Sacramento, San Joaquin and Bay Area districts. Staff met with representatives from Sacramento and Yolo Solano districts regarding control measures to address transport concerns. Staff participated in a workgroup meeting to gather input on the draft Technical Assessment Document for further emissions reductions from organic liquid storage tanks.

Staff wrote four comment letters regarding air quality impacts of development projects and plans in the Bay Area: Central Station Project (Oakland), Vista Del Mar Project (Pittsburg), Parkway Commerce Center (Richmond), BEA Development Project (San Jose). A letter was also sent to each city manager and county administrator in the region providing information about air quality benefits of tree planting and encouraging cities and counties to incorporate air quality considerations in their tree planting programs.

## PUBLIC INFORMATION & OUTREACH - T. GALVIN LEE, DIRECTOR

The wintertime media relations and outreach program on woodsmoke and driving was completed in February, and planning began for Spare the Air 2004 summertime campaign. The Board approved recommendations for five contractors to assist with the program and staff began to meet with the new contractors to begin program development. Eight Spare the Air employer workshops are being planned for April and May in Santa Rosa, San Francisco, the Peninsula, Sunnyvale, Oakland, West Contra Costa, Central Contra Costa, and the Tri-Valley. To date, six of the sessions are fully sponsored. Staff and the consultant (RIDES) finalized the design and content of the pre-season employer packet. The employer section of the STA website is in the process of being updated.

On February 18th the Oakland Community Environmental Tour was held. Nine board members attended. The Air District's community resource teams worked on a variety of projects. The San Francisco team continued outreach to San Francisco businesses to increase participation in Bike to Work Day, which will be held on May 20. The East Bay resource team developed their Commute Resource Guide. The Napa Clean Air Coalition evaluated progress on its vanpool project and discussed other potential projects for 2004.

1558 smoking vehicles were reported during February.

#### TECHNICAL DIVISION – G. KENDALL, DIRECTOR

## **Air Monitoring**

Particulate monitors for  $PM_{2.5}$ , including six continuous  $PM_{2.5}$  monitors, continued their enhanced wintertime sampling schedules at all designated stations. Ozone monitors at eight stations are shut down during the low ozone winter period as authorized under by a waiver granted by the EPA.

## **Meteorology and Data Analysis**

November 2003 air quality data were reviewed and entered into the EPA Air Quality System (AQS) database. The winter calibration of the District meteorological network was completed. Stubble burn complaints for 2002-2003 were analyzed in preparation for developing Stubble Burn forecasting techniques. Three staff attended the two-day media training course.

#### **Quality Assurance**

The Quality Assurance supervisor met with CARB Standard Lab staff to discuss standard gas and transfer standard certification procedures. A system audit was completed at the District's Vallejo air monitoring station.

## **Air Quality**

There were no days in February when the air quality reached the Unhealthful for Sensitive Groups category (AQI >100) for PM<sub>2.5</sub>. Frequent frontal passages prevented any significant buildup of PM<sub>2.5</sub> at the beginning of the month. A brief period of high pressure with cold nights and offshore flow led to five consecutive days when the air quality rose to the Moderate level (51-100 AQI) during the middle of the month. Several strong storms brought windy, wet conditions with good air quality (AQI < 51) during the last two weeks of the month. Air quality was good between storms due to strong winds. Our Santa Rosa meteorological station recorded 18 days of rain in February.

#### Laboratory

In addition to the ongoing, routine analyses performed by the lab, six ambient air samples collected from the vicinity of the Tesoro incident on 2/20/04 were analyzed for reduced sulfur compounds and total hydrocarbons. One of those samples was further analyzed for toxic compounds and other hydrocarbons. Four coating samples from Rexam Beverage were analyzed for hydrocarbon compounds.

#### **Source Test**

Ongoing Source Test activities included Continuous Emissions Monitoring (CEM) Field Accuracy Tests, source tests, gasoline cargo tank testing, and evaluations of tests conducted by outside contractors. The ConocoPhillips Refinery's open path monitor monthly report for the Month of January was reviewed. The Source Test Section provided ongoing participation in the District's Further Studies Measures for refineries.
