5. Report of the Public Outreach Committee Meeting of January 23, 2006

Action(s): The Committee recommends Board of Director approval to extend for a one-year period contracts that assist with public outreach.

Advertising – O'Rorke Advertising (up to \$867,000)

Media Relations – Allison & Partners (up to \$100,000)

Community Outreach – Community Focus (up to \$165,000)

Employer Program – Allison & Partners (up to \$98,000)

Director Cooper presented the report and stated that the Public Outreach Committee met on Monday, January 23, 2006.

Staff presented recommendations for contractors for public outreach programs and the Committee recommends Board of Director approval to extend for a one-year period the following contracts:

- Youth outreach Communications West (up to \$100,000)
- Advertising O'Rorke Advertising (up to \$867,000)
- Media relations Allison & Partners (up to \$100,000)
- Research and measurement True North Research (up to \$63,000)
- Community outreach Community Focus (up to \$165,000)
- Employer program Allison & Partners (up to \$98,000)

Staff presented a status report on the 2005/2006 Wintertime Outreach Campaign. The wood smoke outreach messages, advertising, and media coverage were discussed. A mid-season wintertime survey was also presented.

The next meeting of the Committee will be at the Call of the Chair.

Board Action: Director Cooper moved that the Board of Directors approve the report and recommendations of the Public Outreach Committee to extend the public outreach program contracts for a period of one year; seconded by Director Miller.

In response to questions from several Directors, it was noted that the funds for the contracts are in the budget, and that surveys are conducted as follow-up on how many people have been reached. There was discussion on the decrease in the contract amounts due to District staff handling some of the work previously performed by the contractors. Director Torliatt requested that in six months, a report be provided to the Public Outreach Committee on the Community Relations Manager position and aspects of contract work that staff is now performing. The motion then carried unanimously without objection.

6. Report of the Legislative Committee Meeting of January 30, 2006

Action(s): The Committee recommended Board of Director approval of the 2006 Legislative Agenda as well as Air District positions on new bills.

Directors Mark DeSaulnier and Liz Kniss arrived at 10:09 a.m.

Draft Minutes of February 1, 2006 Regular Board Meeting

Director Garner presented the report and stated that the Committee met on Monday, January 30, 2006.

Staff presented a summary of recommendations for a 2006 legislative agenda for Board of Director adoption. Two general strategies discussed were reducing goods movement emissions and adding a smoking vehicle component to the smog check program.

Staff discussed the following newly-introduced bills:

- AB 1870 (Lieber) –Requires the incorporation of a visible-smoke test into the smog check program.
- AB 1901 (Horton) Sets up a revolving loan program to retrofit trucks.
- SB 1205 ((Escutia) Increases the civil penalties for specified violations of air pollution laws, and establishes a new category of serious and chronic violations with penalty funds going to the California Air Resources Board and children's health programs.
- AB 1231 (Horton) Requires air districts to submit specified reports to the California Air Resources Board.
- AB 1430 (Goldberg) Deals with the calculation methodology for emission reduction credits.

The Committee provided direction to staff on the items discussed. The next Committee meeting will be at the Call of the Chair.

Board Action: Director Garner moved that the Board of Directors approve the report of the Legislative Committee and adopt the legislative agenda for 2006; seconded by Director Kwok.

In response to questions from Director Torliatt, Jack Broadbent, Executive Officer/APCO, stated that staff was given direction in regards to the reduction of speed for vessels coming into the Bay Area and looking at the potential of upgrades to the Port of Oakland that would result in no-net increase of emissions. Director Townsend requested staff look at the issue of ships with multiple fuel tanks and requiring the vessels to switch to clean diesel when moving at 12 knots. The motion then passed unanimously without objection.

Presentation

7. Presentation regarding California Air Resources Board Memorandum of Understanding (MOU) with Union Pacific (UP) and Burlington Northern Santa Fe (BNSF) Railroads

Staff from the California Air Resources Board (ARB) provided an overview of the MOU between the ARB and the UP and BNSF Railroads.

Mr. Broadbent introduced the item and stated that this Air District, along with others, had concerns about the lack of a public process in the development of the MOU that was signed in June 2005. There now have been a number of public workshops on the MOU and the District is working with CARB and the rail roads to implement the MOU.

Draft Minutes of February 1, 2006 Regular Board Meeting

Jean Roggenkamp, Deputy APCO, provided an overview of the MOU and the five rail yards in the Bay Area that the MOU covers. The goal of the MOU is to reduce diesel emissions at rail yards.

Dean Simeroth from the Air Resources Board provided an overview of the MOU. The overview included discussion on the following:

- Statewide strategy for rail, potential funding mechanisms, and overall emissions goal.
- Overview of the agreement (specific elements and community involvement).
- Clarifications of the agreement and the release clause.
- Progress report on the overall status of activities, including the status of implementation.
- Community-based activities and goods movement emissions reduction strategy.

Mr. Simeroth noted that there is a link on the CARB web site to the MOU.

Ms. Roggenkamp then reviewed the Air District's role, which includes outreach to communities, handling complaints, and assisting with Health Risk Assessments.

Chair Uilkema stated that the topic of the MOU between CARB and the rail roads be referred to the Advisory Council as part of their discussions this year.

FINANCE, ADMINISTRATION AND INFORMATION SERVICES DIVISION – J. McKAY, DIRECTOR

Payroll System Replacement

Work to implement the new Payroll system is ongoing. In the last month particular emphasis was placed on the interface from the eTime time entry system to Ceridian, the interface from Ceridian to the District's General Ledger in JD Edwards, and the return data from Ceridian to the eTime time entry tracking system.

Background: After reviewing the responses to the RFP, and after further interviews, the Budget and Finance Committee approved the selection of Ceridian to replace the District's current ADP payroll system. Work began January 3, 2006 with go-live targeted for new fiscal year July 1, 2006. The Project Management issues associated with this work may have repercussions on other projects (including the Production System) that require senior management oversight.

Annual Audit

Caporicci and Larson completed the initial 2004-2005 staff interviews and submitted an Exit Conference document. They have now begun a ledger review.

COMPLIANCE & ENFORCEMENT DIVISION - K. WEE, DIRECTOR

Enforcement Program

Staff participated in an evening community meeting on January 31, 2006 to discuss Pacific Steel Casting's (PSC) Settlement Agreement with the District and the health risk assessment PSC has undertaken. The meeting was co-hosted by the District and the West Berkeley Alliance for Clean Air and Safe Jobs and was attended by approximately 150 people. District staff discussed air pollution complaint procedures, explained how penalty settlement amounts were determined (state law and limits), and reviewed plans to abate odors. PSC will install carbon adsorption beds with a 90% abatement efficiency at Plant #3, with a mid-October completion date in accordance with a District-imposed deadline. District staff emphasized that they will continue to attend community meetings and local neighborhood association meetings and will provide public records when requested by the community.

Staff attended the Northern California District Attorneys' Association in Berkeley on January 18, 2006 to discuss pending cases within the District's jurisdiction. On January 19, 2006 staff met with Tesoro Refining representatives and the Contra Costa County District Attorney to discuss Notices of Violations associated with Tesoro's Boiler #5 tube rupture that occurred on January 12, 2005.

Compliance Assurance Program

Staff attended the CAPCOA Vapor Recovery Technical Committee meeting in Sacramento on January 11 – 13, 2006. Individual companies are making presentations to the committee about In Station Diagnostics (ISD) systems so that the committee may make recommendations before they are installed and in use. The 18-month In-Use Evaluation Protocol and Cost Effectiveness Review are posted on the CARB website for final comments. To date, eight ISD systems have been installed state-wide, including one in Berkeley. On January 25, 2006 Inspection staff met with representatives of Gilbarco/Veeder-Root and 7-Eleven, Inc., at the District office and on January 27 with station managers at Chevron's offices in San Ramon, to discuss the State's Enhanced Vapor Recovery (EVR) timelines, the use of Phase I "Out-of-Order" tags, requirements for periodic testing and maintenance and tips on how to stay in compliance.

Staff toured the BNSF Railway and Union Pacific Railroad yards on January 17th and 19th, 2006, to familiarize themselves with the rail operations in anticipation of complaint response and enforcement under the Memorandum of Understanding between the rail companies and CARB. Staff attended the Faster Freight and Cleaner Air Conference on Goods Movement that was held in Long Beach, CA, January 30th through February 1st, 2006 to stay current on legislation associated with idling trucks and rail operations.

Compliance Assistance Program

Staff participated in a conference call with the PI&O Division representative and the designated producer on the Napa County Fire Video to review upcoming timelines. The working title of the video is "Hot-n-Clean."

Training

Staff attended an Interviewing and Interrogation Techniques course offered by the California Hazardous Materials Investigators Association (CHMIA), to determine its appropriateness for Inspectors. Staff completed the training calendar for 2006 and proposed topics for the 1st Quarter In-Service Training (IST). Staff is expecting delivery of its new smoke machine for visible emissions evaluation training in February. Operations and CARB staff members will then receive three days of training on its usage.

Operations

Staff met with both the internal and external flare working groups to continue discussions surrounding the implementation of Reg. 12-12. Both groups discussed flare management plans and causal analysis reporting. October 2005 flare data was posted on the District web page. Field sampling for the pilot PM monitoring study took place on Sunday, January 15, 2006 in Santa Rosa. Staff has approved the Asbestos Dust Mitigation Plan for the Spear Street Project in San Francisco. Staff attended the West Oakland Local Advisory Group meeting as an observer for a pesticides remediation pilot program under the Cal/EPA Environmental Justice Action Plan. The advisory group provides input into the DTSC Brownfields cleanup activities and is part of Cal/EPA's objective to develop a more participative decision-making process with local communities. Staff released its request for proposal (RFP) document for the Communication System upgrade project. Staff expects initial contact from interested parties in January and will hold a formal bidders conference on February 6, 2006.

ENGINEERING DIVISION - B. BATEMAN, DIRECTOR

Toxics Program

The Toxic Evaluation Section completed 41 health risk screens during January for new/modified permit applications. The majority of these risk screens were for diesel engine emergency generators and gas stations. Staff also began work on a complex health risk assessment for a major new project at the Chevron Refinery in Richmond, and continued work with consultants preparing a health risk assessment for Pacific Steel Casting in Berkeley. Work continued in conjunction with Occidental College on the Environmental Garment Care Demonstration Project; Blue Sky Cleaners is a new demonstration site now operating in Union City, with multiple carbon dioxide machines and wet cleaning systems. Staff attended a training seminar for AERMOD, EPA's new regulatory air dispersion model, and continued work on projects needed to transition to this model.

Title V Program

Permits were circulated for final internal review for the following Title V renewal permits: City of Santa Rosa (Santa Rosa), Jefferson Smurfit (Santa Clara), Calpine Pittsburg (Pittsburg), and Strongwell (San Jose). The public comment period began for the Title V renewal permit for Owens-Brockway (Oakland).

Permit Evaluation Program

A total of 120 new permit applications were received during January. Staff met with a number of project proponents to discuss permitting issues, including: (1) Valero to discuss their Ultra Low Sulfur Diesel Project at the Benicia refinery; (2) Granite Rock to discuss replacement of a Hot Mix Asphalt Plant in Redwood City; (3) consultants working on the Transbay Cable Project to discuss their plans to run an electrical line to deliver power from Pittsburg to San Francisco; and (4) G.E. Infrastructure Sensing to discuss a facility modification. Staff attended the CAPCOA Engineering Managers Meeting in Los Angeles, and participated in the monthly STAPPA/ALAPCO Permitting Committee Conference Call.

Engineering Special Projects Program

Staff continued participating in the development of a pilot project for the new production database system. A meeting was held with Valero to review record keeping data for an upcoming IERC banking application.

Community Air Risk Evaluation (CARE) Program

Staff received training in the use of GPS devices from Farallon Geographics. Dr. Eric Fujita gave a presentation to staff on current research at Desert Research Institute (DRI) on characterization of VOC, PM and hazardous air pollutant emissions, source contributions, assessment of exposures to hazardous air pollutants, and atmospheric reactions of diesel emissions. The interim CARE program manager attended a UC Environmental Sciences Division Faculty Candidate Job Talk. The candidate has worked on various UCLA/CARB/SCAQMD studies on human exposures to toxic air contaminants, and urban traffic impacts/implications of vehicle-related exposures. Staff also attended the Golden West Section AWMA Session on Community Environmental Monitoring Programs. The District received hydrocarbon analysis results from DRI. District staff will assess these results to gain more clarity on sources of monitored emissions from various types of combustion sources.

LEGAL DIVISION – B. BUNGER, DISTRICT COUNSEL

The District Counsel's Office received 138 Violations reflected in Notices of Violation ("NOVs") for processing.

Mutual Settlement Program staff initiated settlement discussions regarding civil penalties for 98 Violations reflected in NOVs. In addition, Mutual Settlement Program staff sent 13 Final 30 Day Letters regarding civil penalties for 23 Violations reflected in NOVs. Finally, settlement negotiations by Mutual Settlement Program staff resulted in collection of \$16,925 in civil penalties for 26 Violations reflected in NOVs.

Counsel in the District Counsel's Office initiated settlement discussions regarding civil penalties for 2 Violations reflected in NOVs. Settlement negotiations by counsel in the District Counsel's Office resulted in collection of \$137,300 in civil penalties for 46 Violations.

PLANNING DIVISION – H. HILKEN, DIRECTOR

Rule Development Program

Staff received comment on proposed amendments to Regulation 12, Rule 12: Flares at Petroleum Refineries regarding flaring that requires a causal analysis. Staff met with the California Council for Environmental and Economic Balance to discuss development of particulate matter and NOx standards for stationary internal combustion engines and with Bay Area County Health Department officials regarding control of commercial charbroiling operations.

Grant Programs

Staff presented to the Mobile Source Committee: 1) the results of the Transportation Fund for Clean Air (TFCA) Regional Fund audit; 2) a proposal to reallocate Back-Up Generator Mitigation funds to fund hybrid-electric trucks, which was subsequently approved by the Board of Directors; and 3) a comparison of diesel and natural gas fuel costs. At the Board of Directors retreat, staff provided an overview of TFCA evaluation of and funding for bicycle and pedestrian projects. Per the Board's direction, staff will evaluate the consultant's review of such projects currently underway when it is complete, meet with congestion management agencies, develop further recommendations for the TFCA program as necessary to assure that air quality benefits of such projects are well documented, and report back to the Mobile Source Committee. Staff attended a meeting of the Executive Directors of the Bay Area's Congestion Management Agencies and discussed TFCA funding of bicycle and pedestrian projects. Staff started the evaluation of 149 grant applications, totaling \$24.1 million, for the current funding cycle (Year 7) of the Carl Moyer Program. A total of 493 eligible light-duty vehicles were purchased and scrapped by the three Vehicle Buy Back Program contractors.

Air Quality Planning Program

Staff presented the 2005 Ozone Strategy and Final EIR to the Board of Directors at the January 4, 2006 Board of Directors meeting. The Board adopted the Ozone Strategy and certified the FEIR. Staff is continuing work on development of the steering committee for the 2006 Climate Protection Leadership Summit and the integration of climate protection activities with existing District programs. Staff prepared four letters regarding the air quality impacts of development projects and plans in the Bay Area: City of Brisbane – NOP for Slough R&D Development Project; Napa County – NOP for their General Plan; City of Pleasanton – NOP for their General Plan; City of San Jose – DEIR for ISTAR Development Project.

Research and Modeling

Staff participated in AERMOD (the U.S. EPA's new permit model) training. Staff attended an international conference entitled "Applications of Air Pollution Meteorology" in Atlanta, GA and presented two technical papers. Staff participated in the Central California Ozone Study (CCOS) and the California Regional Particulate Air Quality Study (CRPAQS) Technical Committee meetings to follow the progress of these two projects.

PUBLIC INFORMATION & OUTREACH

Staff participated in the KCBS Health Etc, Fair, Saturday, January 28, 2006 at San Francisco's Moscone Center. Executive Officer Jack Broadbent introduced the keynote speaker, psychologist "Dr. Phil" McGraw. Over 5,000 people attended this event.

Staff developed a strategic plan for the summertime Spare the Air/Free Transit campaign, including the concept of "2006 Spare the Air/Free Fare." This would enable Bay Area riders to enjoy free transit for the entire day on the first three non-holiday weekdays.

In early January, the San Francisco Chronicle published an article entitled "Cleaning up the Cleaners: New methods offer alternatives to toxic solvents." Staff was interviewed regarding environmental impacts and the District's financial support of the project. KGO-TV interviewed District staff on the same subject for broadcast this month.

Staff appeared before the West Berkeley community on January 31, 2006 to answer questions regarding the operation and monitoring of the Pacific Steel Casting facility. The meeting, originally scheduled for 7-8:30 p.m., concluded at 10 p.m. More than 100 people attended this event.

Staff organized two community meetings regarding the railyard agreement between ARB and local railroads. Meetings are scheduled for February 7, 2006 (Richmond) and February 8, 2006 (West Oakland). Management and staff also attended tours of the Union Pacific railyard (Jan. 17th) and BNSF's railyard (Jan. 19th).

Staff will be interviewed regarding woodsmoke for Tri-Valley TV30 next week; multiple airings to follow.

Staff began preparations for the Aviation Symposium taking place in Palm Springs, CA in March.

TECHNICAL DIVISION - G. KENDALL, DIRECTOR

Air Quality

Air quality remained in the Good AQI category most of January as a result of the winter storms that passed through the Bay Area. Between storms, particulate levels (PM_{2.5}) reached the Moderate category on 12 days. There were no days with Unhealthy or Unhealthy for Sensitive Groups (USG) air quality levels.

Air Monitoring

Three satellite air monitoring stations, Ellis Street in San Francisco, which measured carbon monoxide, Alice Street in Oakland, which measured ozone and carbon monoxide, and Piedmont Road in San Jose which measured ozone, were closed on December 31, 2005. No exceedances of any of the National or State standards were recorded at Ellis Street or Alice Street for more than 10 years. Although a few exceedances of the very stringent State ozone standard were recorded since 1998 at the Piedmont Street location, no exceedances of the National ozone standards were recorded for more than seven years. These stations were targeted for closure after EPA performed an analysis of the network utilizing the recently update National Air Monitoring Strategy that redirects focus to population exposures, ozone, toxics and particulate matter. EPA and ARB concurrence was obtained prior to shut down. These closures will allow the Air District to redirect resources to more community oriented monitoring projects and toxics monitoring projects. The Crockett station, located at an East Bay MUD's water district facility, has been shut down during seismic upgrades of the facility but is expected to return to service in February.

Meteorology and Forecasting

October 2005 air quality data were quality assured and entered into the EPA Air Quality System (AQS) database. Staff continued to make daily air quality and burn forecasts. Staff also reviewed and made corrections to ozone and particulate tables in the American Lung Association's "State of the Air: 2006."

Quality Assurance

The Quality Assurance (QA) group conducted regular, mandated performance audits of 21 monitors at 10 Air District air monitoring stations. QA Staff continued work on a new mobile surveillance van which will replace an older van.

Laboratory

In addition to ongoing, routine analyses, 15 impinger solutions sampled at the roaster oven outlet stack and cooler outlet of Ghirardelli Chocolate Company in San Leandro were analyzed for organic compounds. Ten cartridges and seven impinger solutions sampled at the outlet of the Waste Management of Alameda County in Livermore were analyzed for formaldehyde by High Performance Liquid Chromatography (HPLC) and colorimetric technique, respectively. Three pulverized coal samples from Hanson Permanente Cement were analyzed for mercury content.

Source Test

Ongoing Source Test activities included Continuous Emissions Monitoring (CEM) Field Accuracy Tests, source tests, gasoline cargo tank testing, and evaluations of tests conducted by outside contractors. The ConocoPhillips Refinery's open path monitor monthly report for the month of December was reviewed. The Source Test Section participated in the District's Rule Development efforts for Refinery Cooling Towers and Gasoline Bulk Terminals.

RECOMMENDED ACTION

Authorize the Executive Officer/APCO to execute all necessary agreements with the California Air Resources Board (CARB) relating to the Air District's receipt of Carl Moyer Program funds for fiscal year (FY) 2005-2006.

BACKGROUND

CARB allocates Carl Moyer Program funds to local air districts to provide financial incentives to the public and private sectors for the implementation of eligible projects that reduce emissions from on-road and off-road diesel powered heavy-duty engines. The Air District has been participating in the Carl Moyer Program since its inception in 1999. The Carl Moyer Program provides a very cost-effective means to reduce emissions of nitrogen oxides, particulate matter, and air toxics from heavy-duty diesel engines.

DISCUSSION

CARB has allocated a total of \$10,517,926 in Carl Moyer Program funds to the Air District for the FY 2005-2006 (Year 8) cycle; this includes \$10,279,963 for project grants, and \$237,962 to help offset the Air District's administrative and outreach costs. Authorization by the Board of Directors to accept these funds is needed to satisfy CARB procedures and to allow the Air District to execute a contract for these funds by CARB's deadline of April 30, 2006. Staff will bring proposed Year 8 Carl Moyer Program guidelines to the Mobile Source Committee and the Board of Directors for review and approval later this year, prior to issuing a call for applications. After evaluating the applications that are submitted, staff will propose a list of recommended grant awards to the Mobile Source Committee and the Board of Directors.

BUDGET CONSIDERATION/FINANCIAL IMPACT

CARB requires the Air District to provide Year 8 matching funds in the amount of \$1,613,302. The Air District will provide the required matching funds by allocating local motor vehicle surcharge revenues to eligible emission reduction projects that qualify for Carl Moyer Program matching purposes.
