## Summary of Board of Directors Personnel Committee Meeting 9:30 a.m., Tuesday, February 28, 2006

1.	Call to Order – Roll Call:		Chairperson Shelia Young called the meeting to order at 9:35 a.m.

- 2. **Public Comment Period:** There were none.
- **3. Approval of Minutes of December 15, 2005:** Director Miller moved approval of the minutes; seconded by Director Kwok; passed without objection with Chairperson Shelia Young abstaining.

Director Miller announced that she is one of the candidates that will be interviewed and recused herself from the meeting.

- 4. Consider Recommending to the Board of Directors a Reassignment to the Transportation Category for 1 Position on the Advisory Council: The Committee Considered recommending to the Board of Directors a reassignment to the Transportation category to fill an unexpired term of office.
- 5. Conduct Interviews and Consider Recommending Applicants to Fill 10 Positions on the Advisory Council: The Committee conducted interviews of candidates to fill ten (10) categories that have expired terms of offices on the Advisory Council.

The Committee discussed the interview process and determined to divide the Committee into two groups to conduct interviews of all candidates; the Committee will then reconvene as a whole for discussion and recommendations for agenda items 4 and 5.

Brian Bunger, Legal Counsel, stated that the current appointee to the Transportation category has announced their intent to resign. One candidate has requested reassignment to the Transportation category as that category is better suited to their experience.

Director Michael Shimansky arrived at 9:50 a.m.

The Committee then conducted 20 interviews. After all of the candidates were interviewed, the Committee reconvened as a whole to discuss the results of the interviews and make recommendations for each of the positions.

**Committee Action:** Director Haggerty moved that the Committee recommend that the Board of Directors reassign Louise Bedsworth to the Transportation Category to fill an unexpired term of office ending December 31, 2006. In addition, Mr. Haggerty moved that the Committee recommend the following appointments to the Advisory Council in their respective categories for a two-year term of office ending December 31, 2007:

### **RECOMMENDED ACTION:**

Conduct interviews and consider recommending Board of Director approval of appointments of candidates to fill one regular Attorney position, one alternate Attorney position and one alternate Medical Profession position on the District Hearing Board.

### BACKGROUND:

Pursuant to Section 40800 of the California Health and Safety Code the District is required to maintain a Hearing Board consisting of five members. Further, section 40801 requires that one of the members is licensed to practice law in California and one of the members is from the medical profession with specialized skills, training, or interests in the field of environmental medicine, community medicine, or occupational/toxicological medicine. Section 40800 also allows the District to appoint one alternate member for each of the position categories, provided that the alternate has the qualifications specified in Section 40801.

### DISCUSSION

The Hearing Board currently has 3 vacancies: one regular Attorney position, one alternate Attorney position and one alternate Medical Profession position. There are 5 candidates for regular and alternate Attorney positions and 2 candidates for the alternate Medical Profession position. All candidates will be interviewed on May 31, 2006. The interviews will begin at 9:40 am. The length of each interview will be approximately fifteen minutes.
