RECOMMENDED ACTION:

Conduct interviews and consider recommending Board of Directors' approval of an appointment to fill the alternate Attorney position on the District's Hearing Board.

BACKGROUND:

Pursuant to Section 40800 of the California Health and Safety Code the District is required to maintain a Hearing Board consisting of five members. Further, section 40801 requires that one of the members is licensed to practice law in California. Section 40800 also allows the District to appoint one alternate member for each of the position categories, provided that the alternate has the qualifications specified in Section 40801.

DISCUSSION

The Hearing Board currently has one vacancy for the alternate Attorney position. There are seven candidates for the alternate Attorney position. All candidates will be interviewed on September 28, 2006. The interviews will begin at 9:40 a.m. The length of each interview will be approximately fifteen minutes.
