Opening Comments

Chair Ross noted that the Board of Directors is going to talk about three different areas during the Retreat; wood smoke, the Port of Oakland, and climate change.

State of the Air District

The Executive Officer/APCO addressed the Board of Directors regarding the state of the Air District.

Jack Broadbent, Executive Officer/APCO stated that the retreat will cover three key policy issues: 1) the status of the District's efforts relative to toxic air contaminants; 2) a wood

smoke discussion; and 3) a climate protection discussion. Mr. Broadbent then provided an overview of the Air District that included the following:

- Administrative overview
- Air District financial highlights
- Air District mid-year financial projections
- The relationship with the Employees' Association
- 2006 Ozone exceedances
- PM 2.5 exceedances based on continuous PM 2.5 monitors from November 1, 2006 to January 15, 2007

- Future efforts and challenges facing the Air District

Director Pamela Torliatt arrived during the presentation at 10:12 a.m.

Overview and Status of Programs to Reduce Toxic Air Contaminants

The Board of Directors received an overview and status report regarding efforts being undertaken by the Air District to reduce community impacts from toxic air contaminants.

Henry Hilken, Director of Planning, Rules & Research, provided an overview of the Community Air Risk Evaluation (CARE) program objectives. The objectives include evaluating community cancer and non-cancer health risk from ambient air toxic contaminants and focuses on health risk mitigation measures on locations with higher risk levels and sensitive populations.

Mr. Hilken presented charts reflecting the cancer toxicity-weighted emissions by pollutant and by source category. Maps indicating areas of concentration of diesel PM10 emissions were reviewed. High concentrations of diesel sources in West Oakland come from trucks, locomotives, ships, harbor craft, cargo handling equipment, and construction. The Air District is working with the Air Resources Board on a West Oakland health risk assessment (HRA). Three complementary studies are being done at the maritime Port of Oakland, the Union Pacific railyard, and adjacent West Oakland. It is anticipated the results will be available in the Spring or Summer of 2007.

Mr. Broadbent continued the presentation and stated that the CARE Program identifies areas of ports as having high emissions. The three HRAs are expected to indicate significant high risk in neighboring communities. Other HRAs of diesel emissions have been done at the Roseville railyard and the ports of Los Angeles and Long Beach.

Mr. Broadbent stated that the Port of Oakland needs to catch up with the rest of the state.

- Progress to date has been slow even though there have been extensive discussions.
- Significant progress is being made by the Ports of Los Angeles and Long Beach.
- Opportunities exist to achieve cost-effective emissions reductions in Oakland.
- An approach is needed to assure reductions are made and made expeditiously.

Draft Minutes of January 17, 2007 Regular Board Meeting and Retreat

Options to assure emission reductions include the following:

- To continue as is.
- Target Carl Moyer funding.
- Pursue regulatory approaches.

The recommendation is to pursue a regulatory effort backed up with a commitment to provide resources. The concept is based on the Flare Minimization Plan required by the refineries. During discussion it was noted that there are several other ports within the Bay Area and that they should also be taken into consideration when developing a regulation. Director Uilkema stated that it is important to establish that the Air District has some regulatory authority over the ports. Chair Ross stated that a new Ad Hoc Committee regarding the ports will be established.

Presentation on Comprehensive Wood Smoke Strategy

The Board of Directors received a presentation on efforts being undertaken to address pollution from wood smoke.

Kelly Wee, Director of Compliance and Enforcement, presented the report and stated that in 1990, the Air District adopted a model wood smoke ordinance. The District staff has been working with the Advisory Council on this issue and the Advisory Council presented its recommendation to the Board at the Board Executive Committee meeting of December 21, 2006. Mr. Wee presented the following information:

- Background on Particulate Matter (PM2.5) and wood smoke.
- Ambient levels of particulate matter in the District.
- PM health effects.
- Wood smoke is the largest fraction of PM2.5.
- Wood smoke strategy:
 - o Control measures
 - o Outreach
 - o Incentives
- Timeline for rule development, research, outreach, and incentives.
- PM2.5 implementation timeline.

The Board discussed educating the public, burning improper fuels, and notification on wood pallets and the chemicals they contain.

BACKGROUND

The Air District hosted the Bay Area Climate Protection Summit on November 10, 2006 at the Yerba Buena Center for the Arts in San Francisco.

DISCUSSION

The Summit was a success, in bringing together hundreds of Bay Area leaders, garnering media coverage, and positioning the Air District as a climate protection leader. In addition, the Air District announced at the Summit the creation of the \$3 million Climate Protection Grant Program.

Over 500 people attended, including:

- Air District board members and other local elected officials;
- Officials and staff from the Air Resources Board and other State agencies;
- Staff from local governments and other public agencies;
- Representatives from private business and industry;
- High school age and college age individuals active in climate protection; and
- Representatives from nongovernmental organizations, including foundations.

Speakers at the event included:

- Former Chair Gayle Uilkema;
- Executive Officer Jack Broadbent;
- Former Vice President Al Gore;
- Dave Douglas, Sun Microsystems;
- Michel Gelobter, Redefining Progress;
- Michelle Wyman, ICLEI Local Governments for Sustainability;
- Tom King, PG&E;
- Steve Heminger, MTC; and
- Carl Guardino, Silicon Valley Leadership Group.

Five well-attended network discussion sessions were held during the afternoon:

- Policy-makers session, hosted by Timothy Burroughs of ICLEI;
- Business session, hosted by Margaret Bruce of the Silicon Valley Leadership Group and Andrew Michael of the Bay Area Council;
- Nongovernmental Organizations session, hosted by Michel Gelobter of Redefining Progress;
- Transportation session, hosted by Steve Heminger of MTC; and
- Next-Generation session, hosted by Jim Callahan, a 2004 Clean Air Champion, and by Nia Robinson of the Environmental Justice and Climate Change Initiative.

Media coverage of the event was extensive. According to a media coverage report completed in late November, news of the Summit appeared on four Bay Area radio stations, with the story airing a total of seven times. Nine television stations also covered the event, airing the story a total of 24 times and reaching an estimated 1.1 million television viewers. News of the Summit also appeared on eight distinct websites and several print newspapers.

The Summit served as a valuable learning experience not only for the participants, but for District staff as well. Staff plans to maintain contact with the Summit participants and to consider the ideas and concerns they shared at the event as the Climate Protection Program moves forward. Staff will update the committee on program developments as well as progress made by the networking groups since the Summit.

Staff also will discuss the District's climate protection program at the January 17, 2006 Board of Directors' retreat. Based on feedback from Summit participants and direction from the Board retreat, staff will discuss with the Committee potential next steps for the District's climate protection program.

RECOMMENDED ACTION

The Committee recommends that the Board of Directors' approve the addition of one employee position of Supervising Environmental Planner to the current fiscal year budget in the Grants Programs section of the Outreach and Incentives Division.

BACKGROUND

The Budget & Finance Committee met on Wednesday, January 24, 2007. Staff presented the following reports and recommendations:

- ➤ District Financial Overview for Fiscal Year 2007/2008;
- Committee consideration of staff's recommendation to add one Supervising Environmental Planner position to the Grants Program section of the Outreach and Incentives Division.

DISCUSSION

At its January 24, 2007, meeting the Committee requested that staff provide additional information with regard to the Carl Moyer Program allocation for administering the program.

In response to the Committee's request, staff provides the following information: In addition to increasing the District's allocation of statewide Carl Moyer funds, recent revisions to the Carl Moyer Program legislation provide for an increase from 2% to 5% of funds received to cover administrative costs including costs for staff to administer the program. This revision represents an increase from \$250,000 to \$625,000. The addition of a Supervising Environmental Planner would cost approximately \$130,000 including salary and benefits on an annual basis. The FY 2006/2007 budget includes \$492,607 for administering the Carl Moyer Program. For FY 2006/2007, the budgeted amount of \$492,607 will be increased by approximately \$45,000 (to approximately \$537,607).

Attached are the staff reports presented to the Committee.

BUDGET CONSIDERATION/FINANCIAL IMPACT:

Staff's recommendation to add a new position of Supervising Environmental Planner in the Outreach and Incentives Division will result in a budget increase of approximately \$45,000 for the remainder of fiscal year 2006/2007. The funding is budgeted from the Carl Moyer Program grant fund. The annual cost of the new position is approximately \$130,000 per year, including benefits in future fiscal years.

RECOMMENDED ACTION:

DISCUSSION

Entering the FY 07-08 budget season, the District is in excellent financial health and possesses adequate reserves. Staff will present a summary of this status.

On the revenue side, Cost Recovery continues to be a critical element of the District's financial planning. Permit-related costs and support services exceed revenue from these sources. Prior year fee increases across all fee schedules were 7% and 8.5% in the last two years respectively. Consistent attention to this discrepancy prevents the need for larger one-time adjustments. County revenue will continue to reflect the increase in Bay Area property values.

On the expenditure side, the District expects PERS costs to remain flat. Significant capital expenditures have been approved by the Board of Directors, including execution of deferred building maintenance and the replacement of the IRIS/Databank Production System. The District will also introduce preliminary planning for future medical coverage liabilities.

The District is providing support to the state-wide audit of the Carl Moyer program. A summary of these audit processes will be provided to the committee.

Re: Consideration of Recommendation to Add One Employee Position to the Current

Fiscal Year Budget in the Grants Program

RECOMMENDATION:

Recommend Board of Directors' approval of one additional employee position to the current fiscal year budget in the Grant Programs Section of the Outreach and Incentives Division.

BACKGROUND

The District's Carl Moyer Grant funding has increased from \$2.5 million to \$12.5 million. This increase, combined with new compliance rules, has increased workload significantly.

DISCUSSION

The increase in the District's Carl Moyer grant funding, along with new compliance requirements for grant programs recently issued by the California Air Resources Board, need to be addressed through increased staffing. Extensive auditing requirements for grant programs and associated record-keeping exacerbate the workload created by increased funding. A Supervising Environmental Planner position would provide the necessary expertise and coordinative abilities required to administer an expanded program.

BUDGET CONSIDERATION/FINANCIAL IMPACT

Adding a new staff position to the Outreach and Incentives Division will result in a modest increase in personnel costs for the remainder of this fiscal year of approximately \$45,000 that will be funded by grant program revenue (estimate based on new staff working a third of the year). The annual cost of the new position will be approximately \$130,000 per year, including benefits. New legislation regarding the Carl Moyer program authorizes the District to use as much as 5% of Carl Moyer grant funding for staff; more than double the previous authorization of 2%. This change in authorization should ensure adequate funding for the new position.
