The above numbered solicitation is amended as set forth below:

1. "NOTES TO OFFERORS" - Note Q. is hereby amended to read as follows:
 - Q. Two sample research protocols that demonstrate the offerors approach to research activities designed to validate or lead to clinical studies, should be submitted with the proposal: one protocol should be a preclinical research activity and one protocol should be a vaccine-related research activity using human specimens. **Study protocols proposed in Part E do not have to be linked to study protocols proposed in Part A. Protocols may be linked; however, such a linkage is not required.**
2. "SECTION L - INSTRUCTIONS, CONDITIONS AND NOTICES TO OFFERORS" - paragraph e. ESTIMATE OF EFFORT, is hereby amended to read as follows:
 - e. ESTIMATE OF EFFORT

It is expected that completion type contracts will be awarded as a result of this RFP. To assist you in the preparation of your proposal, the Government considers the total 5-year effort to be approximately 248,560 labor hours (2,080 hours equates to 100% effort). This information is furnished for the offeror's information only and is not considered restrictive for proposal purposes. **The effort shown below, represents 1 year only (49,712 hours) and is broken down by part for additional guidance:**
