## SBA Disaster Assistance Still Available; Centers Closing Soon

ATLANTA – The U.S. Small Business Administration announces today the consolidation of Business Recovery Centers and Disaster Loan Outreach Centers in Wisconsin based on the level of activities. The Centers located in Sauk and Jefferson counties will close on September 19<sup>th</sup> at the close of business. The Centers located in Fond du Lac and Milwaukee counties will remain open until September 26<sup>th</sup> to provide services to victims of the June 5 – July 25, 2008 severe storms, tornadoes and flooding.

“We have approved over \$5 Million in Disaster Loans to assist Wisconsin businesses in their recovery from the June floods. It now makes sense to combine these two Business Recovery Centers with the Disaster Loan Outreach Centers. These two centers will continue to be staffed with experienced SBA business personnel,” said Eric Ness, SBA District Director for Wisconsin.

Over \$37 million have been approved in disaster loans for homeowners and businesses in Wisconsin affected by this disaster. The SBA urges homeowners, renters, businesses and non-profit organizations that are disaster victims to visit the Centers before they close to obtain one-on-one assistance.
