

## MAJOR IMPLICATIONS OF OMB CIRCULAR A-130 FOR FEDERAL WEB CONTENT MANAGERS

Following is a brief summary, compiled by the Web Content Management Working Group, of key sections of OMB A-130 that pertain to web management and suggestions for how the guidance impacts federal Web Managers

7a	The Federal Government is the largest single producer, collector, consumer, and disseminator of information in the United States. Because of the extent of the government's information activities, and the dependence of those activities upon public cooperation, the management of Federal information resources is an issue of continuing importance to all Federal agencies, State and local governments, and the public.	<ul style="list-style-type: none"> <li>Your website(s) are a significant means for delivering government information to the public</li> </ul>
7b	Government information is a valuable national resource. It provides the public with knowledge of the government, society, and economy -- past, present, and future. It is a means to ensure the accountability of government, to manage the government's operations, to maintain the healthy performance of the economy, and is itself a commodity in the marketplace.	<ul style="list-style-type: none"> <li>This is a biggie! Government information is, itself, a product that we need to manage effectively.</li> <li>The public depends on our providing this product – and your website(s) can be one of the most efficient and effective ways to do that.</li> </ul>
7c	The free flow of information between the government and the public is essential to a democratic society.
