Notes of Clarification:

A Listed establishments are those with sufficient annual production for FSIS to obtain a timely set (see: http://www.fsis.usda.gov/Science/Scheduling_Criteria_Salmonella_Sets/index.asp).

NOTE: At this time, FSIS is posting only the set results for raw classes of broiler carcasses because a primary focus for the Agency for the last year has been to reverse the prior adverse trend in % positive results that have been particularly marked in broilers; results for all other classes of products will be posted before September 30, 2008.

- B Establishments notifying FSIS that they no longer are producing a raw class of product will be removed from the listing in the next monthly update.
- C By the 15th of each month, FSIS will update and post the "Salmonella Set Category Results For Individual Establishments" for sets completed by the end of the prior month.
- D FSIS expects to begin listing establishments with a Category 1 level of control for Salmonella in CY08, once FSIS initiates collecting unannounced samples in these establishments.
- E Establishments are sorted chronologically by establishment number (by assigned "M" number for livestock product and "P" number for poultry product).
- F If a set is halted by FSIS prior to completion of the set (e.g., exceeds the number of acceptable positives before the end of the set), the results will count as if the full set was completed.

Terminology:

- A "category" means the assigned level of process control for Salmonella results collected by FSIS (see: 71 FR 9772, 2/26/06)
- B "at or below half" means the number of positives in the set are at or below half the number of acceptable positives as stated in either 9 CFR (310.25(b)(1) or 381.94(b)(1)) or 70 FR 8058, 2/15/2005.
- C "above half but not exceeding" means the number of positives in the set are above half but not exceeding the number of acceptable positives as stated in either 9 CFR (310.25(b)(1) or 381.94(b)(1)) or 70 FR 8058, 2/15/2005.
- D "exceeding" means the number of positives in the set are above the number of acceptable positives as stated in either 9 CFR (310.25(b)(1) or 381.94(b)(1)) or 70 FR 8058, 2/15/2005.
- E "not available" means that only one sample set forms the basis for the category level, possibly due to the establishment being new or recently slaughtering or processing this class of raw product.
