ORDERS FOR PUBLIC PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

INTERNATIONAL RESEARCH & MANAGEMENT CORP.,
RICHARD D. BRAVERMAN

The Commission has instituted public administrative proceedings under the Investment Company Act of 1940 and the Investment Advisers Act of 1940 against International Research & Management Corp. (IRM), a registered investment adviser, and Richard D. Braverman (Braverman), its president and director. The Commission's order is based on staff allegations that Braverman and IRM breached their fiduciary duties to a registered investment company (Registrant) and committed a fraud upon Registrant, their client, by borrowing the assets of Registrant and converting them to their own use.

A hearing will be scheduled to take evidence on the staff's allegations and to afford the respondents an opportunity to offer any defenses. The purpose of the hearing is to determine whether the allegations are true and if any action of a remedial nature should be ordered by the Commission. (Rel. IC-9360)

INVESTMENT COMPANY ACT RELEASES

SWISS AMERICAN SECURITIES INC.

A notice has been issued on an application of Swiss American Securities Inc. (SASI) pursuant to Section 9(c) of the Act, providing that the Secretary shall issue an order exempting SASI from the provisions of Section 9(a) of the Act if no interested person submits a written request for a hearing not later than August 22, 1976. The application results from an entry of an injunction, upon consent, against Swiss Credit Bank in SEC v. American Institute Counselors, Inc. et al. 75 Civ. 1965, in the U.S. District Court for the District of Columbia. (Rel. IC-9358)

HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation, a registered holding company, to acquire an interest in the development and sale of an automatic meter reading system by an unaffiliated company. (Rel. 35-19618 - July 20)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

DELISTING GRANTED

An order has been issued granting the applications of the Midwest Stock Exchange, Inc. to strike from listing and registration the specified security of the following companies: Bliss & Laughlin Industries, Inc. (common stock), Foremost-McKesson, Inc. (common stock and cumulative preferred stock, Series A, convertible, \$35 par).

Their has been little trading volume on the Midwest Stock Exchange in both of these companies securities. The common stock of Bliss & Laughlin Industries, Inc. remains listed and registered on the New York Stock Exchange, Inc. The common and preferred stocks of Foremost-McKesson, Inc. remain listed on the New York and Pacific Stock Exchanges; the common stock retains unlisted trading privileges on the Philadelphia and Boston Stock Exchanges. NOTICE OF EFFECTIVENESS OF A RULE CHANGE

A rule change filed by The Options Clearing Corporation (OCC) pursuant to Rule 19b-4 (SR-OCC-76-6) has become effective in accordance with Subsection 19(b)(3) of the Securities Exchange Act of 1934. The rule change amends OCC's by-laws by redefining the term "series of options." (Rel. 34-12645)

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the New York Stock Exchange, Inc. The rule change (SR-MYSE-76-31) provides a procedure for disapproving applications for membership, association with a member, and access to services provided by the Exchange. (Rel. 34-12623)

The Commission has approved a proposed rule change (SR-SCCP-76-2) filed by the Stock Clearing Corporation of Philadelphia (SCCP) clarifying the status of SCCP's liens on stock carried in SCCP's members' accounts and procedures regarding members' use of SCCP's depository facility to hypothecate securities with participating banks. (Rel. 34-12642)

The Commission has approved a proposed rule change filed by the Municipal Securities Rulemaking Board. The rule change (SR-MSRB-76-3) establishes a fidelity bonding requirement for municipal securities brokers and non-bank municipal securities dealers and by its terms becomes effective 90 days after Commission approval. The Commission is currently considering other rules filed with the fidelity bonding rule. (Rel. 34-12644)
