APPROVAL OF FINGERPRINT PLAN SUBMITTED BY THE MIDWEST U.S. SECURITIES AND STOCK EXCHANGE, INC. AND AMENDMENTS TO PLANS OF BOSTON EXCHANGE COMMISSION

The Commission announced the approval of a fingerprint plan submitted by the Midwest Stock Exchange, Inc. for a five-month pilot period beginning August 1, 1976 and ending December 31, 1976, pursuant to paragraph (c) of Rule 17f-2 under Section 17(f)(2) of the Securities Exchange Act of 1934. Under the terms of the plan, the exchange will collect fingerprint cards submitted by its members, forward the cards to the Attorney General of the United States for identification and appropriate processing, and return the fingerprint cards and any information received as a result of such processing to the submitting members.

The Commission also announced the approval of amendments to the plans of the Boston Stock Exchange, Inc. and the National Association of Securities Dealers, Inc. Under the terms of the amendments, the Boston Stock Exchange will transmit fingerprint records for employees and associated persons of non-bank registered transfer agents for issues solely listed on the exchange, Massachusetts-chartered bank transfer agents, and non-member New England securities firms. Under the terms of the NASD amendment, the association will transmit fingerprint records for employees and associated persons of non-bank registered transfer agents for NASDAQ-listed securities and of SECO brokers and dealers. NOTICE OF ORDER GRANTING NASDAQ, INC. AN EXTENSION OF THEIR TEMPORARY EXEMPTION FROM REGISTRATION AS A SECURITIES INFORMATION PROCESSOR

The Commission has ordered, pursuant to Section 11A(b)(1) of the Act, that the ninety day exemptive period following publication of notice of the NASDAQ, Inc. application for registration as a securities information processor is extended as of July 6, 1976 until September 20, 1976. (Rel. 34-12688)

TRADING SUSPENSIONS

TRADING SUSPENDED IN MICRON CORP.

The SEC has announced the single ten-day suspension of exchange and over-the-counter trading in the securities of Micron Corp., a Utah corporation located in Salt Lake City, Utah, for the period beginning on August 6 and terminating at midnight (EDT) on August 15, 1976. The Commission ordered the suspension in Micron's securities at the request of Micron because of the lack of public information about certain adverse corporate developments which have recently come to the Commission's attention.

The Commission has been informed that Micron's president, certain other key officers, and all directors have resigned and a recent review of Micron's first quarter of 1976 financial statements indicates that that quarter's results previously released may be in error. In addition, the firm's accountants have been unable to develop reliable information for the second quarter of 1976. Micron's major creditor is taking possession of all the company's assets after having given notice of default to Micron, leaving the company with no assets, and all the company's employees are being terminated. INVESTMENT COMPANY ACT RELEASES

CONTRAN CORPORATION

An order has been issued on an application of Contran Corporation declaring that it has ceased to be an investment company and terminating its registration under the Act subject to the Commission's retention of such jurisdiction as it may have with respect to a legal settlement and the transactions to be effected pursuant thereto which are the subject of a pending application under Sections 17(b) and 23(c) of the Act. NOTICE OF PROPOSED RULE CHANGE

The Midwest Securities Trust Company has filed, pursuant to Rule 19b-4, a proposed rule change (SR-MSTC-76-9) to allow certificates representing stock dividends and similar distributions in respect of securities in pledged positions to be credited to the account of the pledgee, rather than the pledgor.
