DECISIONS IN ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

PHILIP RICHMAN SANCTIONED

The Commission has suspended Philip Richman of Houston, Texas from association with any broker or dealer for 90 days and thereafter barred him from association with any broker or dealer in a supervisory capacity provided that one year after association in a supervised capacity he may make application for reassociation in a supervisory capacity. The santions against Richman were based on findings that Richman had wilfully violated the registration and antifraud provisions of the securities laws, and had wilfully aided and abetted violations of the books and records provisions of the securities laws. Without admitting or denying the charges against him, Richman consented to the above findings and sanctions. (Rel. 34-12864)

HOWARD SHERMAN SUSPENDED

The Commission has suspended Howard Sherman of Bronx, New York from association with any broker or dealer for 90 days. The sanctions against Sherman were based on findings that Sherman had wilfully violated the registration and antifraud provisions of the securities laws. Without admitting or denying the charges against him, Sherman consented to the above findings and sanctions. (Rel. 34-12865)

RONALD HELLER SUSPENDED

The Commission has suspended Ronald Heller of Flushing, New York from association with any broker or dealer for 10 days. The sanctions against Heller were based on findings that Heller had wilfully violated the registration and antifraud provisions of the securities laws. Without admitting or denying the charges against him, Heller consented to the above findings and sanctions. (Rel. 34-12866)

CHARLES H. ELDREDGE & CO., INC.

Charles H. Eldredge & Co., Inc., a registered investment adviser, and Charles H. Eldredge, Jr., its president, failed to answer the order that instituted proceedings and are therefore in default. Accordingly, the registration as an investment adviser of Charles H. Eldredge & Co., Inc. has been revoked; and Charles H. Eldredge Jr. has been barred from being associated with any investment adviser. The proceedings were instituted May 6, 1976. (Rel. IA-541)
