DECISIONS IN ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

CHARLES B. COSSE' SUSPENDED

The Commission has issued an order suspending Charles B. Cosse', president of Cosse' International Securities, Inc., a Seattle broker-dealer, from association with any broker-dealer or investment adviser for a period of 90 days. Cosse' may, however, become re-associated with the firm after a period of 60 days in a supervised, non-supervisory capacity. The Commission also censured Cosse' International Securities, Inc. The Commission's order is based upon an offer of settlement submitted by Cosse' and the firm in which respondents consented to the sanctions. The order of proceedings upon which the settlement was based alleged that Cosse' and the firm wilfully violated the registration and antifraud provisions of the securities laws. (Rel. 34-12943)

INVESTMENT COMPANY ACT RELEASES

AMERICAN INCOME INVESTMENTS

A notice has been issued giving interested persons until December 3 to request a hearing on an application of American Income Investments, Inc., a registered open-end diversified management investment company, for an order declaring that it has ceased to be an investment company. NEW ENGLAND POWER COMPANY

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved proposed changes to Rule 304 filed by the Options Clearing Corporation under Rule 19b-4 (SR-OCC-76-3) relating to clearing members' financial responsibility. (Rel. 34-12958)

The Commission has approved a proposed rule and constitutional change package filed September 20 by the Boston Stock Exchange. The changes (SR-BSE-76-3) amend the Exchange's disciplinary procedures and rules regarding access to the facilities of the Exchange. (Rel. 34-12959)

The Commission has approved a proposed rule change by the TAD Depository Corporation (SR-TAD-76-2) to implement a collateral loan service. (Rel. 34-12961)

NOTICE OF PROPOSED RULE CHANGE

The Municipal Securities Rulemaking Board has filed a proposed rule change under Rule 19b-4 (SR-MSRB-76-10) to reduce the underwriting assessment for municipal securities brokers and municipal securities dealers.
