ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST PAINE WEBBER JACKSON & CURTIS, INC.

The Commission announced the institution of a public administrative proceeding, pursuant to Section 15(b) of the Securities Exchange Act of 1934 (Exchange Act), against Paine Webber Jackson & Curtis, Inc., a broker-dealer registered with the Commission under Section 15(b) of the Exchange Act and a member of the New York, American, Pacific and other stock exchanges. The Order for Proceedings alleged that during the period June 6 through June 23, 1980, Paine Webber, by means of the mails and instrumentalities of interstate commerce and facilities of national securities exchanges, directly and indirectly, wilfully violated and wilfully aided and abetted a violation of Section 14(d) of the Exchange Act in connection with the acquisition by Simpson Paper Company of 9.9 percent of the common stock of Diamond International Corporation on June 12, 1980. INVESTMENT COMPANY ACT RELEASES

GOVERNMENT SECURITIES CASH FUND

HOLDING COMPANY ACT RELEASES

CONNECTICUT YANKEE ATOMIC POWER COMPANY

An order has been issued releasing the jurisdiction reserved in an order dated April 17, 1981 (HCAR No. 22011), over the terms of and the fees, commissions and expenses to be incurred in connection with a proposed placement of up to \$75 million of debentures to be issued and sold by Connecticut Yankee Atomic Power Company, subsidiary of New England Electric System and Northeast Utilities, each a registered holding company. Retention of jurisdiction in this proceeding is no longer necessary since the matters over which jurisdiction has been reserved are dealt with in an order to issue concurrently in File No. 70-6636.
