#### CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A notice has been issued giving interested persons until February 24 to request a hearing on a proposal by Central and South West Corporation (CSW), a registered holding company, and its wholly owned subsidiary, CSW Energy, Inc. (Energy). CSW and Energy propose to invest up to \$10 million in a joint venture to be formed with EnerTran Technology Company to invest in independent power production facilities, qualifying small power production facilities and qualifying cogeneration facilities. Energy also proposes to organize a subsidiary company through which its investments in the joint venture will be made. (Rel. 35-25463)

#### GENERAL PUBLIC UTILITIES CORPORATION, ET AL.

A notice has been issued giving interested persons until February 24 to request a hearing on a proposal by General Public Utilities Corporation (GPU), a registered holding company, and its wholly owned subsidiary companies, Jersey Central Power & Light Company (JCP&L), Metropolitan Edison Company (Met-Ed) and Pennsylvania Electric Company (Penelec) (collectively, GPU Companies). The GPU Companies request authorization through March 31, 1995 to issue, sell and renew unsecured promissory notes in amounts up to \$150 million at any one time and maturing not more than six months from the date of issue, to certain banks under the terms of a revolving credit agreement. The GPU Companies also request authorization through March 31, 1995 to issue, sell and renew their unsecured promissory notes pursuant to loan participation arrangements and informal lines of credit in amounts up to the limitations on shortterm indebtedness contained in their respective charters and, in the case of GPU, \$200 million. Finally, the GPU Companies request to incur other short-term unsecured debt, from time to time, in amounts up to the limits permitted by their respective charters and, in the case of GPU, \$200 million; and, in the case of JCP&L, Met-Ed and Penelec, to issue and sell their respective unsecured promissory notes as commercial paper in amounts up to their respective charter limits. #### NEW ENGLAND POWER COMPANY

A notice has been issued giving interested persons until February 24 to request a hearing on a proposal by New England Power Company (NEPCO), an electric publicutility subsidiary company of New England Electric System, a registered holding company. NEPCO proposes to enter into one or more interest rate swap agreements (Swaps) on or before December 31, 1996 not to exceed an aggregate notional amount of \$617 million. The order also grants KPL a temporary exemption under Section 3(a)(2) from all provisions of the Act except Section 9(a)(2). (Rel. 35-25465)

#### PENNSYLVANIA ELECTRIC COMPANY

An order has been issued authorizing a proposal by Pennsylvania Electric Co. (Penelec), an electric public-utility subsidiary company of General Public Utilities, a registered holding company. Penelec proposes to sell to Advanced Cast Products, Inc., a nonassociate company, for a cash purchase price of \$140,000 certain electric substation facilities and equipment located in Vernon Township, Crawford County, Pennsylvania. SYSTEM FUELS, INC., ET AL.

An order has been issued authorizing a proposal by System Fuels, Inc. (SFI), a fuel procurement company, and two of its parent companies, Louisiana Power & Light Company and Arkansas Power & Light Company, each an electric public-utility subsidiary company of Entergy Corporation (Entergy), a registered holding company, and by System Energy Resources, Inc., also an electric public-utility subsidiary of Entergy. SFI proposes to amend a credit agreement between SFI and The Yasuda Trust and Banking Co., Ltd., New York Branch, as agent for a group of lenders, in order to extend such credit agreement's expiration date through September 30, 1994 and increase the commitment fee. A proposed rule change (SR-CBOE-92-01) filed by the <u>Chicago Board Options Exchange</u> has become effective under Section 19(b)(3)(A) of the Securities Exchange Act. The

proposed rule change modifies the Exchange's arrangement of expiration months for Standard & Poor's 500 Stock Index (SPX) options to allow the Exchange to list three consecutive month series of SPX options together with three far-term quarterly SPX expirations. Publication of the order is expected in the <u>Federal Register</u> during the week of February 10. (Rel. 34-30330)

A proposed rule change (SR-CBOE-91-48) filed by the <u>Chicago Board Options Exchange</u> has become effective under Section 19(b)(3)(A) of the Securities Exchange Act. The proposed rule change consolidates current CBOE policy and procedures regarding permissible joint account trading activity in equity option crowds without a Designated Primary Market Marker. Publication of the order is expected in the <u>Federal Register</u> during the week of February 10. (Rel. 34-30334)

#### PROPOSED RULE CHANGE

The <u>American Stock Exchange</u> filed a proposed rule change (SR-Amex-92-03) under Rule 19b-4 to list and trade index warrants based on the Japan Index, a price-weighted index of 210 leading common stocks actively traded on the Tokyo Stock Exchange. Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
