# ADMINISTRATIVE PROCEEDINGS

NASD ACTION AGAINST LOWELL LISTROM, MARCO LISTROM AND STEPHEN MOCK AFFIRMED

The Commission has affirmed sanctions imposed by the NASD on Lowell H. Listrom (Lowell) and Marco R. Listrom (Marco), both of Kansas City, Missouri, and Stephen L. Mock of Overland Park, Kansas. Lowell was board chairman of Lowell H. Listrom & Company, Inc., a former NASD member firm, Marco was president of the firm, and Mock a vice president. The NASD censured respondents and imposed the following individual sanctions: Lowell - a \$25,000 joint and several fine with the firm and a bar from association with any member as a general securities principal; Marco - a \$5,000 fine and a requirement that he requalify as a general securities principal by examination within 60 days; and Mock - a \$5,000 fine, a 10 calendar-day suspension, and a requirement that he requalify as a financial and operations principal by examination.

The Commission affirmed the NASD's findings that during 1987 Lowell, Marco and Mock were responsible for the firm's failure to comply with net capital, recordkeeping and customer protection provisions. In affirming the sanctions imposed by the NASD, the Commission reiterated that the rules respondents violated were not technical but involved "fundamental safeguards imposed for the protection of the investing public." The Commission noted that Lowell, the most severely sanctioned of the three respondents, had "a disquieting history of prior infractions." (Rel. 34-30497)

# CIVIL PROCEEDINGS

MONTANA NATURALS INT'L., INC., RONALD HAUGE AND MARK BAKER ENJOINED

The Commission announced on March 4 that the Honorable Charles C. Lovell, U.S. District Judge for the District Court for the U.S. District Court for the District of Montana, Missoula Division, permanently enjoined Montana Naturals Int'l., Inc. (MTNA), a publicly-traded company registered with the Commission; Ronald Hauge, President and CEO of MTNA; and Mark Baker, a former employee and independent auditor of MTNA, from violating the antifraud, filing and books and recordkeeping provisions of the federal securities laws. The complaint alleged that Hauge and Baker caused MTNA to file Forms 10-Q and 10-K with the Commission during 1988 and 1989 containing financial statements which, among other things, overstated inventory and accounts receivable. ## CERTIFIED PUBLIC ACCOUNTANT ENJOINED

The Commission announced that on March 2 the U.S. District Court for the Western District of Arkansas entered a Final Judgement of Permanent Injunction against Leroy P. Studer enjoining him from further aiding and abetting violations of the reporting provisions of the Securities Exchange Act of 1934. Studer consented to the Final Judgement without admitting or denying the Commission's allegations.

Studer, a certified public accountant located in Newport Beach, California, is the auditor for Gemini Energy Corporation, a Section 12(g) reporting company which was also permanently enjoined in the same civil action. According to the Commission's complaint, the defendants misrepresented in Commission filings and news releases Gemini's financial condition, including title to and the value of certain oil and gas leases; and the existence of legal proceedings affecting the company's properties and officers. # INVESTMENT COMPANY ACT RELEASES

AMA FAMILY OF FUNDS, INC.

## COLLEGE RETIREMENT EQUITIES FUND, ET AL.

A notice has been issued giving interested persons until April 20 to request a hearing on an application filed by College Retirement Equities Fund (CREF), Teachers Insurance and Annuity Association of America (TIAA) and College Credit Trust (Trust) (collectively, Applicants). The application is for an order of the Commission pursuant to Sections 6(c), 17(b) and 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The order would exempt Applicants from the provisions of Section 17(a) and granting the necessary approvals under Section 17(d) and Rule 17d-1 thereunder. The exemptions would apply to the extent necessary to permit Applicants to participate in the Trust and for CREF to acquire TIAA's investment in the Trust and for TIAA to sell, either directly or through a redemption of TIAA's investment in the Trust, such interest to CREF. TIAA and the College Entrance Examination Board have created the Trust for the purpose of making educational loans, and CREF will be the principal investor. The Student Loan Marketing Association will administer the Trust and the loans and provide related services. (Rel. IC-18630 - March 24)

# SELF-REGULATORY ORGANIZATIONS

# PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-91-05) that would amend Schedule I to the NASD By-Laws, which governs the operation of the PORTAL Market and any trading effected in PORTAL securities. The PORTAL Market was established to provide a marketplace for primary distributions and secondary trading meeting the requirements of Rule 144A under The Securities Act of 1933. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 30. (Rel. 34-30508)

# APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the <u>National Association of Securities Dealers</u> which amends Article III, Section 27 (g)(2) of the Rules of Fair Practice to amend the definition of "branch office." The rule change codifies existing interpretations of Section 27 (g)(2), which were published by the NASD to clarify for members the activities that trigger the branch office registration requirement. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 30. (Rel. 34-30509)
