Following is a schedule of Commission meetings which will be conducted under provisions of the Government in the Sunshine Act. In general, the Commission expects to follow a schedule of holding closed meetings on Tuesdays, and open meetings on Thursday mornings. The subject matter of the May 19 closed meeting will be: Settlement of administrative proceedings of an enforcement nature; Institution of administrative proceedings of an enforcement nature; Institution of injunctive actions; and Settlement of injunctive actions.

OPEN MEETING - THURSDAY, MAY 21, 1992 - 2:30 P.M.

The subject matter of the May 21 open meeting will be:

1. Consideration of whether to adopt amendments to Rule 52, and whether to issue for comment further proposed amendments to the same rule and to Rule 45(b)(4), under the Public Utility Holding Act of 1935. Rule 52 exempts certain financings by publicutility subsidiaries of registered holding companies, provided that eight conditions are met. The amendment to Rule 52 would eliminate the six nonstatutory conditions and would extend the exemption to all mortgage bonds rather than first mortgage bonds alone. The proposed amendment to Rule 52 would exempt additional public-utility financings, as well as certain nonutility financings, subject to certain conditions. The proposed amendment to Rule 45(b)(4) would remove a current dollar limitation on capital contributions and open account advances, without interest, by a holding company to its subsidiary company. 2. Consideration of whether to issue a release soliciting public comment on the appropriateness of certain amendments to Rules 3b-3 and 10a-1 under the Securities Exchange Act of 1934 (Exchange Act). Rule 10a-1 generally requires a person selling an exchange-listed security to determine whether that person has a net long position in the security. The determination of a person's net position under Rule 3b-3, which defines the term "short sale" for purposes of the Exchange Act, requires the person to aggregate all of his positions in the security. If the person does not have a net long position, then the "uptick" provisions of Rule 10a-1 apply to the person's sale transactions.

The release proposes amendments to Rule 10a-1 under the Exchange Act that would provide for a new equalizing exception to the Rule to accommodate certain international transactions and exclude from the Rule's application transactions in non-convertible corporate bonds listed and effected on an exchange. The release also proposes amendments to Rule 10a-1 under the Exchange Act that would codify (with modifications) an existing interpretive position relating to the liquidation of certain index arbitrage positions. In addition, the release proposes amendments to Rule 10a-1 under the Exchange Act that would make several clarifying and technical amendments to the Rule. The proposed amendment to Rule 3b-3 under the Exchange Act would modify the definition of ownership of a security. FOR FURTHER INFORMATION CONTACT: George Scargle at (202) 504-2503.

ADMINISTRATIVE PROCEEDINGS

CHARLES HOWARD, III BARRED

The Commission instituted public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act against Charles H. Howard, III (Howard), a former Director and First Vice President of Thomson McKinnon Securities, Inc., a now-defunct New York brokerage firm. The Order, based on Howard's Offer of Settlement, bars Howard from association with any broker, dealer municipal securities dealer, investment adviser or investment company.

On April 8, 1992, the U.S. District Court for the District of New Hampshire permanently enjoined Howard from violating Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. The complaint alleged that Howard, a former investment banker for Suffield Savings Bank of Suffield, Connecticut (Suffield), misappropriated material non-public information regarding the proposed 1986 merger of Suffield and Coastal Savings Bank of Portland, Maine (Coastal). The complaint charged that Howard improperly disclosed non-public information relating to Suffield's proposed merger with Coastal to a business associate, who then purchased Coastal stock, later realizing an unlawful profit of \$21,407.95 (See, SEC v. Charles H. Howard, III, No. C-91-288-L, District of New Hampshire, LR-12908). (Rel. 34-30674)

CIVIL PROCEEDINGS

PERMANENT INJUNCTIONS ENTERED AGAINST THREE COATED DEFENDANTS

The Commission announced today that the U.S. District Court for the District of New Jersey entered Final Judgments of Permanent Injunction and Other Relief as to Bruce Bloom on March 30, 1992 and as to Preston Davis and Michael S. Weinstein on April 28, 1992 in connection with the complaint filed against them on October 26, 1990 (See, LR-12684, AAER No. 282, October 26, 1990). Without admitting or denying the allegations of the Commission's complaint, the defendants consented to the entry of permanent injunctions enjoining them from violating, variously, the antifraud, registration, proxy and recordkeeping provisions of the federal securities laws. Weinstein was also enjoined from serving as an officer or director of any company with securities registered with the Commission. The defendants were each ordered to disgorge profits received as a result of their illegal conduct and to pay penalties pursuant to the Insider Trading Sanctions Act of 1984.

The Commission's complaint charges Weinstein, former Chairman and Chief Executive Officer of Coated Sales, Inc. (Coated), Bloom, former Chief Financial Officer, and Davis, former Assistant Controller, for their participation in a multi-million dollar financial fraud through which Coated reported dramatic increases in sales and earnings between fiscal years 1986 and 1988. The complaint alleges that the defendants inflated Coated's sales and earnings through the creation of false accounts receivable and inventory.

The Commission's action against the remaining defendants is pending. [SEC v. Michael S. Weinstein, Ernest Glantz, Richard Bober, Bruce Bloom, Denis Lustig, Jerry Bernstein and Preston Davis, USDC for the District of New Jersey, Newark Division, Civil Action No. 90-4276, AJL, JR] (LR-13239)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-92-11) to modify the subscriber charge payable for receipt of last-sale information for securities included in NASDAQ. Publication of the proposal is expected in the Federal Register during the week of May 18. (Rel. 34-30689)

The <u>American Stock Exchange</u> filed a proposed rule change (SR-Amex-92-12) to reduce from one-eighth to one-sixteenth the minimum tick fluctuation for premiums between \$300 and \$500 for long-term, reduced-value index options trading. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 18. (Rel. 34-30694)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-MSE-92-05) filed by the <u>Midwest Stock Exchange</u> to make the assignment fee of its membership dues and fees applicable only in competitive assignments has become effective immediately upon filing with the Commission. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 18. (Rel. 34-30692)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-92-18) which has been granted accelerated approval. The rule change extends for 6 months the operation of the NASD's Pilot Program with the Stock Exchange of Singapore, Limited (SES). During the proposed extension, each market will continue to transmit to the other static price/volume information compiled at the end of each trading day on 35 NASDAQ securities. No substantive changes in the nature of the link are approved for implementation during the extension. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 18. (Rel. 34-30695)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
