# COMMISSION ACCEPTS OFFER OF SETTLEMENT OF BACARDI CORPORATION

The Commission announced on May 8 that public administrative proceedings were instituted in the matter of Bacardi Corporation pursuant to Section 12(g)(4) of the Securities Exchange Act of 1934 (Exchange Act) on June 9, 1988. The proceedings were instituted to determine whether the certification contained in the Form 15 filed by Bacardi Corporation (Bacardi) on May 14, 1987 was untrue concerning the number of holders of record identified on the records maintained by or on behalf of Bacardi on May 14, 1987.

On February 15, 1990, an administrative law judge's initial decision (Initial Decision) concluded that certain trusts were identified as holders on records of security holders maintained by or for Bacardi on May 14, 1987 and that the holders of record identified on such records on May 14, 1987 numbered more than 300. Accordingly, the administrative law judge ordered that termination of registration be denied and that all reports as to which the filing obligation had been suspended during the pendency of the proceedings be filed.

Bacardi petitioned the Commission for a review of the Initial Decision and prior to any decision by the Commission, submitted an Offer of Settlement. The Commission determined to accept Bacardi's Offer of Settlement in which it neither admitted nor denied the Commission's findings contained in the Initial Decision and undertook to file a current Form 10-K. This report will include information that would have been filed during the period in which the filing obligation was suspended. (Rel. 34-30681)

# CIVIL PROCEEDINGS

#### CIVIL ACTION AGAINST PAUL KUTIK

The Commission announced on May 14 that it filed a complaint in the U.S. District Court for the Southern District of New York against Paul Kutik seeking injunctive relief, disgorgement and interest thereon. The complaint was based on Kutik's alleged violations of Sections 7(f), 9(a)(1) and 10(b) of the Securities Exchange Act of 1934

(Exchange Act) and Rule 10b-5 thereunder, and Section 3(b) of Regulation X, promulgated by the Federal Reserve Board. The complaint alleges that, beginning in or around June 1990 until at least September 21, 1990, Kutik engaged in a scheme to support artificially the price of the common stock of Columbia Laboratories, Inc. by placing purchase orders for millions of dollars worth of Columbia common stock without the intent or ability to pay for those orders on a timely basis and by effecting wash sales and matched orders. The complaint alleges that Kutik's scheme was motivated by a need to maintain Columbia's stock price at or above \$9 per share in order to avoid the sale of collateral or requirement of additional collateral under the terms of certain loan agreements. #### SELF-REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGE

The <u>Philadelphia Stock Exchange</u> filed a proposed rule (SR-PHLX-92-11) to adopt Options Floor Procedure Advice (OFPA) B-7 regarding priority parity and rules for foreign currency options. The proposed OFPA also includes a fine schedule for violations of these rules in accordance with the Exchange's Minor Infraction Rule Plan. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 18. (Rel. 34-30693)

# APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>New York Stock Exchange</u> (SR-NYSE-92-05) to amend its interpretation of NYSE Rule 452 to give member organizations a "may vote" in respect of initial approvals of investment company contracts. (Rel. 34-30697)
