CRIMINAL PROCEEDINGS

WALTER F. KUSAY, JR. PLEADS GUILTY

The United States Attorney for the Northern District of Illinois and the Securities and Exchange Commission (Commission) announced that on May 27, 1992, Walter F. Kusay, Jr. (Kusay) of Homewood, Illinois, pled guilty in the Northern District of Illinois to a one-count criminal information charging him with mail fraud. According to the information, Kusay misappropriated over \$1.47 million of customer funds given to him for investment purposes and converted these funds to his own personal use. Kusay's sentencing in this matter is scheduled for August 18, 1992.

On May 16, 1989, the Commission had filed a civil injunctive action against Kusay charging him with violations of the federal securities laws as a result of the same activities that were the basis for the criminal information. Thereafter, on July 12, 1989, the Commission obtained an order of permanent injunction against Kusay. [U.S. v. Walter F. Kusay, Jr., 92CR-389, U.S.D.C. N.D. III.] (LR-13259)

GARY E. GAILBRAITH CONVICTED

The Securities and Exchange Commission and the U.S. Attorney for the District of Utah announced that on April 30, 1992, Gary E. Galbraith (Galbraith) of Spokane, Washington, was convicted by a jury of one count of wire fraud.

On April 11, 1990, Galbraith was indicted in a multiple-count indictment charging him with conspiracy, securities fraud, wire fraud, and nonregistration of securities. The indictment alleged that Galbraith and three others conspired to obtain and control the stock of Tzaar Corporation and then to fraudulently manipulate trades in the Tzaar stock. The alleged final goal was to sell the Tzaar stock at an artificially-inflated price to a European pension fund.

The wire fraud count on which Galbraith was convicted related to a telephone conversation that took place between Galbraith and another defendant on September 24, 1989. Two of Galbraith's co-defendants earlier pled guilty to various charges in the indictment and in separately-filed informations. [United States of America v. Gary E. Galbraith, U.S. District Court for the District of Utah, Central Division, Criminal Action File No. 90-CR-0090J] (LR-13261)

INVESTMENT COMPANY ACT RELEASES

SBC PORTFOLIO MANAGEMENT INTERNATIONAL, INC.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by SBC Portfolio Management International, Inc. (PMI). PMI

seeks an order under Section 9(c) of the Act for itself and its affiliated persons who in the future register as investment advisers under the Investment Advisers Act or as broker/dealers under the Securities Exchange Act (Affiliates). The order would exempt PMI and the Affiliates from the disqualification provisions of Section 9(a) of the Act solely with respect to an injunction entered against Swiss Bank Corporation, PMI's parent corporation, in 1975. AIM CONVERTIBLE SECURITIES, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting AIM Convertible Securities, Inc., et al. from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder to the extent necessary to permit applicants to acquire securities of certain foreign issuers engaged in securities related activities in accordance with the conditions of the proposed amendments to Rule 12d3-1. (Rel. IC-18750; International Series Rel. 394 - June 3)

OPPENHEIMER ASSET ALLOCATION FUND, ET AL.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by Oppenheimer Asset Allocation Fund, et al. for a conditional order under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder to permit the operation of joint trading accounts for the purpose of investing in repurchase agreements.
