#### COMMISSION ANNOUNCEMENTS

SEC MARKET OVERSIGHT AND FINANCIAL SERVICES ADVISORY COMMITTEE MEETING

# ADMINISTRATIVE PROCEEDINGS

#### MICHAEL LISKIEWICZ BARRED

The Commission announced the entry of an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions against Michael J. Liskiewicz (Liskiewicz).

Liskiewicz consented to the issuance of the Order without admitting or denying the Commission's findings. The Order, which permanently barred Liskiewicz from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer, contained findings that on December 19, 1991, an Order of Permanent Injunction was entered against Liskiewicz, by consent, in SEC v. Michael J. Liskiewicz, et al., Civil Action File No. 5-91-122, District of Minnesota, enjoining him from violating Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 promulgated thereunder. In that action, the Commission alleged that from at least 1988 to the present, Liskiewicz and his wholly owned company, Superior Capital Corporation, through the fraudulent offer and sale of securities, raised at least \$800,000 from at least 57 investors. The money raised was used by the defendants for personal and business expenses and to pay back earlier investors. (Rel. 34-30831)

#### CIVIL PROCEEDINGS

#### PERMANENT INJUNCTIONS ENTERED AGAINST TWO COATED DEFENDANTS; JERRY BERNSTEIN BARRED

The Commission announced today that the U.S. District Court for the District of New Jersey entered Final Judgments of Permanent Injunction and Other Relief as to Ernest Glantz, former principal, director and President of Coated Sales, Inc. (Coated), on June 16 and as to Jerry Bernstein, a certified public accountant and former Controller of Coated, on June 4, in connection with the complaint filed against them on October 26, 1990 (See LR-12684, AAER No. 282, October 26, 1990). Without admitting or denying the allegations of the Commission's complaint, Glantz and Bernstein consented to the entry of permanent injunctions enjoining them from violating, variously, the antifraud, registration, proxy and recordkeeping provisions of the federal securities laws. Glantz was also enjoined from serving as an officer or director of any company with securities registered with the Commission. The defendants were each ordered to disgorge profits received as a result of their illegal conduct and to pay penalties pursuant to the Insider Trading Sanctions Act of 1984.

Bernstein also consented to the entry of an Order Instituting Public Proceedings Pursuant to the Rule 2(e) of the Commission's Rules of Practice and Opinion and Order of the Commission, permanently denying him the privilege of appearing or practicing before the Commission as an accountant.

The Commission's complaint alleges that Glantz and Bernstein participated in a massive financial fraud at Coated in the years 1985 through 1988. The complaint alleges that the defendants engaged in a scheme to inflate Coated's sales and earnings through, among other acts, the creation of phony invoices purporting to show sales of goods by Coated. SUMMARY JUDGMENT AGAINST CHARLES SHOOK, C.P.A. TO ENFORCE COMMISSION SUBPOENA DUCES TECUM

The Commission announces that on June 5 the Honorable Donald L. Graham of the U.S. District Court for the Southern District of Florida rendered summary judgment against Charles G. Shook, C.P.A. (Shook) of Richmond, Texas and ordered Shook to comply with a subpoena duces tecum (SDT) for testimony and production of documents. The SDT was issued in the matter of Care-Med Centers, Inc.

The complaint alleged Shook failed to comply with a valid subpoena to produce information relevant to the Commission investigation. [SEC v. Charles G. Shook, C.P.A., Case No. 91-2437-CIV-GRAHAM] (LR-13279)

#### INVESTMENT COMPANY ACT RELEASES

THE ALLIANCE FUND, INC., ET AL.

An order has been issued under Section 6(c) of the Investment Company Act to amend a prior order that exempts The Alliance Fund, Inc., et al. from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder. (Rel. IC-18805 - June 23)

MILLS VALUE FUND, INC.

An order has been issued on an application filed by Mills Value Fund, Inc. under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-18806 - June 23)

#### SEPARATE ACCOUNT LL OF LAMAR LIFE INSURANCE COMPANY

An order has been issued pursuant to Section 8(f) of the Investment Company Act declaring that Separate Account LL of Lamar Life Insurance Company has ceased to be an investment company. (Rel. IC-18807 - June 24)

XEROX FINANCIAL SERVICES LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Xerox Financial Services Life Insurance Company, Xerox Variable Annuity Account Four (Account) and Xerox Life Sales Company from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Account under certain variable annuity contracts. (Rel. #### HOLDING COMPANY ACT RELEASES

CORRECTION RE DOMINION RESOURCES, INC., ET AL.

An incorrect paragraph was reported under the heading DOMINION RESOURCES, INC., ET AL. in the June 24th issue of the Digest. The paragraph should have read as follows: A notice has been issued giving interested persons until July 16, 1992 to request a hearing on a proposal by Dominion Resources, Inc. (Dominion), a Virginia publicutility holding company exempt from registration under Section 3(a)(1) of the Act pursuant to Rule 2, and Dominion Energy, Inc. (Dominion Energy), its wholly owned nonutility subsidiary company. Dominion and Dominion Energy propose to acquire an interest in an Argentine public-utility company that will own an electric generating station with a capacity of approximately 98 MW. (Rel. 35-2558)

#### SELF-REGULATORY ORGANIZATIONS

#### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the <u>National Association</u> of <u>Securities Dealers</u> (SR-NASD-92-6) which amends Part III, Section 1 of Schedule D to the NASD By-Laws. The amendment requires that the NASD review an issuer's past corporate governance activities both on and after withdrawal from the NASDAQ National Market System (NASDAQ/NMS), or a securities exchange which imposes corporate governance requirements prior to granting an issuer NASDAQ/NMS designation. Such review will be for the purpose of determining whether an issuer's withdrawal from NASDAQ/NMS or a securities exchange and a subsequent application to NASDAQ/NMS was for the purpose of evading NASDAQ/NMS or the exchange's corporate governance criteria. Publication of the approval order is expected in the <u>Federal Register</u> during the week of June 29. (Rel. 34-30840)

The Commission approved a proposed rule change submitted by the <u>Pacific Stock Exchange</u> (SR-PSE-92-08) that classifies options on the PSE Technology Index as European-style options. Publication of the approval order is expected in the <u>Federal Register</u> during the week of June 29. (Rel. 34-30855)

## ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change (SR-PSE-92-17) filed by the <u>Pacific Stock Exchange</u> that extends the PSE's Trading Crowd Firm Disseminated Market Quote (ten-up Rule) pilot program through August 14, 1992. Publication of the approval order is expected in the <u>Federal Register</u> during the week of June 22. (Rel. 34-30841)

## IMMEDIATE EFFECTIVENESS PROPOSED RULE CHANGE

A proposed rule change (SR-MSE-92-07) filed by the <u>Midwest Stock Exchange</u> to amend its Certificate of Incorporation has become effective immediately upon filing with the Commission. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 22. (Rel. 34-30844)

The <u>Municipal Securities Rulemaking Board</u> filed a proposed rule change (SR-MSRB-92-5) concerning transactions in municipal collateralized mortgage obligations (CMOs). The proposed rule change clarifies that the requirement of MSRB Rule G-15(a) to state yield on confirmations does not apply to CMOs. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 29. (Rel. 34-30856)
