# ADMINISTRATIVE PROCEEDINGS

### DIMITRI BALATSOS SANCTIONED

The Commission announced that it has ordered Dimitri Balatsos, a portfolio manager employed by a registered investment adviser (Adviser), to permanently cease and desist from committing or causing any violation, and committing or causing any future violation, of Sections 206(2) and 206(3) of the Investment Advisers Act of 1940 and to pay a \$15,000 penalty.

In its Order, the Commission found that on September 12, 1990, Balatsos caused two of his clients to purchase bonds issued that day by the International Bank for Reconstruction and Development (World Bank). The Commission found that on September 25, 1990, Balatsos caused one of the clients to purchase the other client's bonds at the original issuance price, even though the bonds were quoted at a lower price in the secondary trading market on that day. The Commission found that Balatsos caused the Adviser to violate Section 206(3) by failing to obtain the purchasing client's consent to the September 25 transaction prior its completion. The Commission also found that Balatsos caused the Adviser to deliver to the purchasing client portfolio summaries which incorrectly reflected that the purchasing client bought all of its World Bank bonds in only one transaction occurring on September 12. # ADMINISTRATIVE PROCEEDINGS AGAINST ANDREW LIGGET

The Commission instituted an administrative proceeding pursuant to Rule 2(e) of the Commission's Rules of Practice against Andrew Ligget, the former Chief Financial Officer of American Continental Corporation. The Commission accepted Ligget's Offer of Settlement pursuant to which he is denied the privilege of appearing before the Commission as an accountant. The proceeding is based upon the entry of a Permanent Injunction against violations of various antifraud, reporting and proxy provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934, and upon Ligget's plea of guilty to three counts of willful misapplication of bank funds. ### INVESTMENT COMPANY ACT RELEASES

VAN ECK FUNDS, ET AL.

A notice has been issued giving interested persons until September 15, 1992 to request a hearing on an application filed by Van Eck Funds, Van Eck Trust, Van Eck Associates Corporation, and Van Eck Securities Corporation for a conditional order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder. The order would permit certain series of the Van Eck Funds and the Van Eck Trust to issue two classes of shares representing interests in the same portfolio of securities, one of which would convert into the other class after a specified period permitting investors to benefit from lower Rule 12b-1 distribution fees. The order would also permit certain series of the Van Eck Funds and the Van Eck Trust to assess a contingent deferred sales charge (CDSC) on certain redemptions of shares of one of the classes and to waive the CDSC under certain circumstances. The order would apply only to those series that invest substantially all of their assets in another registered investment company. (Rel. IC-18904 - August 21)
