U.S. SECURITIES EXCHANGE CONMISSION

RULES AND RELATED MATTERS

REGULATORY FLEXIBILITY AGENDA AND RULES SCHEDULED FOR REVIEW

The Commission announced today the publication of its October 1992 Regulatory Flexibility Agenda. The agenda is intended to provide advance notice to the public of rulemaking actions which may have a significant economic impact on a substantial number of small entities. Public comments regarding individual items in the agenda are due by December 31, 1992. (Rels. 33-6956, 34-31179, 35-25630, 39-2290, IC-18947 and IA-1334; File No. S7-30-92)

INVESTMENT COMPANY ACT RELEASES

DEAN WITTER AMERICAN VALUE FUND, ET AL.

A notice has been issued giving interested persons until October 6, 1992 to request a hearing on an application filed by Dean Witter American Value Fund, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder. The exemptions apply to the extent necessary to permit them to invest in equity or convertible securities issued by foreign issuers that, in their most recent fiscal years, derived more than 15% of their gross revenues from their activities as a broker, dealer, underwriter, or investment adviser, provided such investments meet the conditions described in proposed amended Rule 12d3-1. (Rel. IC-18945; International Series Rel. 455 - September 11)

UNITED STATES TRUST COMPANY OF NEW YORK

A notice has been issued giving interested persons until October 6, 1992 to request a hearing on an application filed by United States Trust Company of New York for a conditional order under Section 6(c) of the Investment Company Act exempting applicant from the provisions of Section 26(a)(2)(D) of the Act. The order would permit applicant to deposit foreign securities, held by unit investment trusts for which it serves as trustee, with the securities clearance and depository facilities operated by Morgan Guaranty Trust Company of New York in Brussels, Belgium in its capacity as operator of the Euroclear System, or with Central de Livraison de Valeurs Mobilieres, S.A. (Rel. IC-18946; International Series 456 - September 11)

HOLDING COMPANY ACT RELEASES

APPALACHIAN POWER COMPANY

A notice has been issued giving interested persons until October 5, 1992 to request a hearing on a proposal by Appalachian Power Company, an electric public-utility subsidiary company of American Electric Power Company, Inc., a registered holding company, to effect the refunding of up to \$50 million of pollution control revenue bonds issued in connection with the financing of pollution control facilities. (Rel. 35-25629)

UNITIL CORPORATION

A notice has been issued giving interested persons until October 5, 1992 to request a hearing on a proposal by UNITIL Corporation (UNITIL), a registered holding company. UNITIL proposes to double the number of its shares of outstanding common stock, no par value, through a two-for-one stock split. (Rel. 35-25629)

CENTRAL AND SOUTH WEST CORP., ET AL.

A notice has been issued to provide all interested persons until October 5, 1992 to request a hearing on a proposal by Central and South West Corporation, a registered holding company, and its non-utility subsidiary companies, CSW Energy, Inc., CSW Development-I, Inc., and ARK/CSW Development Partnership to invest in and develop the Lowville Cogeneration Project (Project), a 49.9-MW gas-fired cogeneration facility to be constructed near Lowville, New York. The Project will be a qualifying facility under the Public Utility Regulatory Policies Act of 1978 and the rules and regulations adopted thereunder by the Federal Energy Regulatory Commission. WEST TEXAS UTILITIES COMPANY

A notice has been issued giving interested persons until October 5, 1992 to request a hearing on a proposal by West Texas Utilities Company (West Texas), an electric public-utility subsidiary company of Central and South West Corporation, a registered holding company. West Texas proposes to issue and sell up to an aggregate principal amount of \$150 million of First Mortgage Bonds (Bonds), in one or more series, from time to time through December 31, 1994. The proceeds from the sale of the Bonds will be used to redeem previously issued and outstanding First Mortgage Bonds. (Rel. 35-25629)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

DELISTING GRANTED

An order has been issued granting the application of the <u>American Stock Exchange</u> to strike from listing and registration PNF Industries, Inc., Common Stock, \$.0001¢ Par Value. (Rel. 34-31178)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-PHLX-91-41) to clarify that the PHLX's late night/early morning foreign currency option trading session is separate from the day and evening trading sessions for purposes of the Exchange's agent/principal prohibition imposed on Registered Options Traders (ROTs). The agent/principal trading prohibition provides that, with respect to an option on the same underlying interest, a ROT cannot act as a floor broker and trade for his own proprietary account during the same trading session. Publication of the proposal is expected in the <u>Federal Register</u> during the week of September 14. (Rel. 34-31171; International Series Rel. 452)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The <u>Participants Trust Company</u> filed a proposed rule change (SR-PTC-92-10) relating to the relocation of PTC's primary processing site from New York to New Jersey. The rule change has become effective on filing with the Commission. Publication of the proposal is expected in the <u>Federal Register</u> during the week of September 14. (Rel. 34-31176)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
