CIVIL PROCEEDINGS

COMPLAINT AGAINST JOHN ARNOLD

The Commission announced that on August 31, 1992 a complaint was filed in the U.S. District Court for the Southern District of Illinois against John E. Arnold, alleging violations of the antifraud and broker-dealer registration provisions of the federal securities laws.

The complaint alleges that from about October 1990 through October 1991, while employed as a registered representative by Independent Financial Securities, Inc., a registered broker-dealer, Arnold misappropriated in excess of \$200,000 from the accounts of at least seven of his customers. The complaint alleges that Arnold took funds entrusted to him by customers for investment in low-risk mutual funds and used them for his personal benefit. The complaint also alleges that Arnold diverted to himself in excess of \$38,000 in commission income by conducting approximately \$1,300,000 worth of private securities transactions through E.C.I. Investments, an entity wholly owned by Arnold. E.C.I. Investments was not registered with the Commission as a broker-dealer.

On March 31, 1992, Arnold pled guilty to one count of mail fraud for some of the same conduct as that alleged in the complaint filed by the Commission. Arnold has been sentenced to 27 months imprisonment and ordered to make restitution of approximately \$250,000. [SEC v. John E. Arnold, USDC, S.D. INVESTMENT COMPANY ACT RELEASES

VANTAGE MONEY MARKET FUNDS

A notice has been issued giving interested persons until September 22 to request a hearing on an application filed by Vantage Money Market Funds for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-18913 - August 28)

SMITH BARNEY EQUITY FUNDS, INC., ET AL.

A notice has been issued giving interested persons until September 22 to request a hearing on an application filed by Smith Barney Equity Funds, Inc., et al. for an order under Section 6(c) of the Investment Company Act granting an exemption from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and rule 22c-1 thereunder. The order would permit applicants to issue three classes of shares representing interests in the same portfolio of securities, and to impose and, under certain circumstances, waive a contingent deferred sales charge on certain redemptions of their shares. PARTNERS INCOME FUND

An order has been issued under Section 6(b) of the Investment Company Act and under section 206A of the Investment Advisers Act (Advisers Act) exempting Partners Income Fund and other employees' securities companies created by McKinsey & Company, Inc. from most provisions of the Act. The order also exempts the investment advisers to such companies from one disclosure requirement of Form ADV under the Advisers Act. (Rel. IC-18948; IA-1335 - September 14)

FX CURRENCY MUTUAL FUND, INC.

A notice has been issued giving interested persons until October 9, 1992 to request a hearing on an application filed by FX Currency Mutual Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-18949 - September 14)

CALVERT CASH RESERVES, ET AL.

A notice has been issued giving interested persons until October 13, 1992 to request a hearing on an application filed by Calvert Cash Reserves (doing business as Money Management Plus), Calvert Tax-Free Reserves, First Variable Rate Fund for Government Income (doing business as Calvert First Government Money Market Fund), Calvert Social Investment Fund, Calvert Asset Management Company, Inc., and Calvert Securities Corporation. The application is for a conditional order under Section 6(c) of the Investment Company Act seeking an exemption from the provisions of Sections 18(f), 18(g), and 18(i) so that the money market portfolios of certain investment companies may issue two classes of securities for each of their money market portfolios. Such classes will be identical in all respects except for differences relating to distribution plan expenses, transfer agency fees, voting rights and class expenses. (Rel. IC-18950 -September 15)

HOLDING COMPANY ACT RELEASES

CENTRAL POWER AND LIGHT COMPANY

A notice has been issued giving interested persons until September 21 to request a hearing on a proposal by Central Power and Light Company (CPL), an electric publicutility subsidiary company of Central and South West Corporation, a registered holding company. CPL proposes to issue and sell through December 31, 1994 up to \$800 million of first mortgage bonds (New Bonds). The proceeds of the New Bonds will be used principally to redeem all or a portion of one or more series of CPL's outstanding first mortgage bonds and to repurchase CPL's outstanding 8.72% preferred stock. TRUST INDENTURE ACT RELEASES

PUBLIC SERVICE ELECTRIC AND GAS COMPANY

The Commission has issued a notice giving interested persons until October 9, 1992 to request a hearing on an application by Public Service Electric and Gas Company (Company), a New Jersey corporation, pursuant to Section 304(c)(1) of the Trust Indenture Act of 1939. The Company requests that the Commission order an exemption from the provisions of Section 316(a)(1) of the Act for certain First and Refunding Mortgage Bonds (Bonds) under an indenture dated as of August 1, 1924, as amended by the Supplemental Indenture dated March 1, 1942, between the Company and Fidelity Union Trust Company (now First Fidelity Bank, National Association, New Jersey) as Trustee (Indenture), which will be supplemented by a separate supplemental indenture providing for each series of Bonds to be dated the first day of the month in which each such series of Bonds is issued.

Section 304(c)(1) of the Act provides in part that the Commission shall exempt from one or more provisions of the Act any security issued or proposed to be issued under an indenture under which securities (as defined in that section) are outstanding if and to the extent that the Commission finds that compliance with such provisions, through the execution of a supplemental indenture or otherwise would require by reason of the provisions of such indenture or of any other indenture or agreement made prior to enactment of the Act, or the provisions of any applicable law, the consent of holders of securities outstanding under such indenture or agreement.
