ADMINISTRATIVE PROCEEDINGS

ROBERT VALERIUS BARRED

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Robert C. Valerius of Denver, Colorado. Simultaneously, the Commission accepted Valerius' Offer of Settlement. The Commission found that Valerius was convicted, pursuant to a plea of guilty, of conspiracy to violate the antifraud provisions of the securities laws in U.S. v. Robert C. Valerius, Crim. No. 91-CR-271, USDC, Colo., and was enjoined from violating the antifraud provisions of the securities laws in SEC v. Robert C. Valerius, Civil Action No. 92-A-1642, USDC Colo., on September 1, 1992.

The Commission also found that the complaint alleged, among other things, that Valerius participated with others in planning and effecting a scheme to artificially increase the price of the securities of Oxford Financial, Inc. through a prearranged merger and a series of trades in securities accounts controlled by himself and coconspirators.

The Commission's order bars Valerius from association in any capacity with any broker, dealer, investment adviser, investment company or municipal securities dealer. (Rel. 34-31180)

R. TAYLOR MATTHEWS, JR. ORDERED TO CEASE AND DESIST

The Commission announced that on September 17 it entered an Order pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) that R. Taylor Matthews, Jr. (Matthews) permanently cease and desist from committing or causing any violation of, or any future violation of, Section 16(a) of the Exchange Act and Rules 16a-2 and 16a-3 promulgated thereunder. The Commission simultaneously accepted Matthews's Offer of Settlement in which, without admitting or denying the matters set forth in the Order, Matthews consented to its issuance. The Order finds that since May 1987, Matthews of St. Louis, Missouri has been a director and the owner of more than ten percent of the common stock of Direct Pharmaceutical Corporation (Direct), a Delaware corporation with its principal offices in St. Louis, Missouri. It also finds that Matthews failed for four and one half years, from May 1987 until December 1991, to file a Form 3 and filed fifteen Forms 4 reporting transactions in excess of \$9.6 million from 21 to 221 weeks late with respect to his investments in Direct's common stock in violation of Section 16(a) of the Exchange Act and the rules thereunder. THE FORTIUS III FUND, INC.

WESTLB FINANCE USA INC., ET AL.

A notice has been issued giving interested persons until October 13, 1992 to request a hearing on an application filed by WestLB Finance USA Inc., et al. for an order under Section 6(c) of the Investment Company Act exempting applicant from the provisions of Subparagraphs (a)(1) and (a)(3) of Rule 3a-5 under the Act. The order would permit applicant to offer and sell its debt securities and use the proceeds to finance the business activities of its parent company without registering as an investment company under the Act.
