AMENDMENTS TO RULE 144A

The Commission has adopted amendments to Rule 144A under the Securities Act of 1933. The Rule provides a safe-harbor exemption from registration for offers and sales exclusively to "qualified institutional buyers" (QIBs). The new provisions have amended the definition of QIB to include collective and master trust funds, which are commonly used for the collective investment of pension and other employee benefit plan monies, as legal forms that may be QIBs. The amendments have recognized purchases by an insurance company for separate accounts not required to be registered under the Investment Company Act of 1940 as purchases for the account of the insurance company. Finally, the amendments allow the inclusion of U.S. government and similar securities in calculating the amount of securities owned or invested by a particular institutional investor. ADOPTION OF AMENDMENTS TO SIMPLIFY REGISTRATION PROCEDURES FOR PRIMARY SECURITIES OFFERINGS

The Commission has published a release adopting changes to rules and forms under the Securities Act of 1933 and the Securities Exchange Act of 1934 designed to simplify the securities registration process. The amendments expand the availability of Form S-3, the short-form registration statement under the Securities Act, to additional classes of issuers and transactions.

The amendments to Form S-3 result in the extension of Rule 415, the shelf registration rule, to a greater variety of offerings, including investment grade asset-backed securities. The initiatives also include other revisions to Form S-3 to enhance its efficiencies, as well as revisions to other Securities Act and Exchange Act rules to facilitate the registration process. RULE 10b-6 UNDER THE SECURITIES EXCHANGE ACT OF 1934 - PASSIVE MARKET MAKING

At an open meeting on October 21 the Commission announced the publication of a release soliciting public comment on the adoption of a new exception to Rule 10b-6 and new companion rule under the Securities Exchange Act of 1934. The proposals would permit "passive market making" during distributions of certain NASDAQ securities designated as "National Market System" securities. In general, a passive market maker's bids would be limited by the level of bids of market makers who are not participating in the distribution. The new provisions would allow "passive market making" during the two business day "cooling-off" period of Rule 10b-6, that is, the period when the Rule's provisions would otherwise prohibit such transactions. The new exception, to be designated as Exception (xiv)(T) to Rule 10b-6, and the new rule are being proposed on a temporary basis in response to a petition for rulemaking filed by the National Association of Securities Dealers. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>New York Stock Exchange</u> (SR-NYSE-90-39) to amend NYSE Rule 72 to allow a member who has a customer order to buy and a customer order to sell 25,000 shares or more of the same security to execute those orders as a cross transaction without interference at the proposed cross price. The proposal, however, would allow the cross to be broken up at a price that is better than the proposed cross price for one side or the other. (Rel. 34-31343)
