## COMMISSION ANNOUNCEMENTS

## INCREASE IN PRICES FOR PHOTOCOPYING SERVICES

Effective November 2, 1992, the prices for all photocopying services, including Freedom of Information Act requests, available through the Commission are raised \$.02 per page. These changes are being made in conformance with the Commission's dissemination contract which provides for annual review and adjustment of pricing levels. ## CIVIL PROCEEDINGS

## TEMPORARY RESTRAINING ORDER ENTERED AGAINST DARRELL EUBANK

The Commission announced that on October 16 the Honorable James L. Graham of the U.S. District for the Southern District of Ohio entered a Temporary Restraining Order against Darrell R. Eubank (Eubank). The Order enjoins Eubank from violations of the antifraud provisions of the federal securities laws. The Order also freezes all of the assets of defendant Eubank and Relief Defendant Sandra Eubank and requires them to provide an accounting to the Court.

The complaint alleges that as part of a fraudulent scheme, Eubank offered and sold securities to investors, requiring them to purchase the securities by checks made payable to him. Thereafter, Eubank failed to purchase the securities and instead used the funds for his own undisclosed personal use. [SEC v. Darrell R Eubank, No. C2-92-944, S.D. Ohio] (LR-13415)

## INVESTMENT COMPANY ACT RELEASES

THE PHOENIX EDGE SERIES FUND, ET AL.

An order has been issued pursuant to Section 17(b) of the Investment Company Act exempting the Phoenix Edge Series Fund (Phoenix Fund) and Home Life Equity Fund (Home Equity Fund) from the provisions of Section 17(a) of the Act to the extent necessary to permit the transfer of the assets of the Home Equity Fund to the Growth Series of the Phoenix Fund. (Rel. IC-19042 - October 21)

PRUDENTIAL-BACHE STRATEGIC INCOME FUND, INC.

A notice has been issued giving interested persons until November 16, 1992 to request a hearing on an application filed by Prudential-Bache Strategic Income Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-19043 - October 21)

THE FINLAND FUND, INC.

A notice has been issued giving interested persons until November 16, 1992 to request a hearing on an application filed by The Finland Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. ## CARNEGIE-CAPPIELLO TRUST

An order has been issued under Section 8(f) of the Investment Company Act declaring that Carnegie-Cappiello Trust has ceased to be an investment company. (Rel. IC-19045 - October 21)

#### PRUDENTIAL CALIFORNIA MUNICIPAL FUND

An order has been issued under Section 6(c) of the Investment Company Act on an application filed by Prudential California Municipal Fund, et al. The order amends a prior order that permitted certain open-end investment companies to sell two classes of shares representing interests in the same portfolio of securities. The order deletes a condition of the prior order that required the directors/trustees of the investment companies to divide their purchases of fund shares equally between the classes of shares offered by a fund. ## LIBERTY MUTUAL CAPITAL CORPORATION (BOSTON)

A notice has been issued giving interested persons until November 16, 1992 to request a hearing on an application filed by Liberty Mutual Capital Corporation (Boston) for an order under Section 6(c) of the Investment Company Act that would grant an exemption from the provisions of Subparagraphs (b)(2)(i) and (b)(3)(i) of Rule 3a-5 under the Act. The requested order would permit applicant to sell certain debt instruments and use the proceeds to finance the business activities of its parent company, Liberty Mutual Insurance Company (Liberty Mutual) and certain subsidiaries of Liberty Mutual. ## SELF-REGULATORY ORGANIZATIONS

#### PROPOSED RULE CHANGE

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-Phlx-92-24) to permit trading in Buy-Write Options Unitary Derivatives (BOUNDs), long-term options with a duration of up to 60 months which have the same economic characteristics as covered calls. The Phlx also proposes to amend its existing rules to permit the listing of long-term equity options (LEAPs) with a duration of up to 60 months. Publication of the proposal is expected in the <u>Federal Register</u> during the week of October 26. (Rel. 34-31346)
