INVESTMENT COMPANY ACT RELEASES

NATIONAL INTEGRITY LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until November 20, 1992 to request a hearing on an application filed by National Integrity Life Insurance Company, Separate Account SFN of National Integrity Life Insurance Company (Separate Account) and Integrity Financial Services, Inc. The application is for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under certain individual and group variable annuity contracts. (Rel. IC-19052 - October 26)

INTEGRITY LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until November 20, 1992 to request a hearing on an application filed by Integrity Life Insurance Company and Separate Account SF of Integrity Life Insurance Company (Separate Account) for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under certain individual and group variable annuity contracts. (Rel. IC-19053 - October 26)

THE GOLDMAN SACHS GROUP, L.P., ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting certain institutional limited partners of The Goldman Sachs Group, L.P. (GS Group), et al. from the definition of "affiliated person" contained in Section 2(a)(3), where the limited partners do not own, control or hold with the power to vote 5% or more of the outstanding voting securities of the partnership. The requested relief would permit the limited partners to sell commercial paper and other financial instruments to, and engage in other transactions with, registered investment companies advised or distributed by certain entities that are affiliated persons of GS Group. (Rel. IC-19057 - October 27)

AMC INVESTORS, INC.

An order has been issued on an application filed by AMC Investors, Inc. under Section 8(f) of the Investment Company Act declaring that is has ceased to be an investment company. (Rel. IC-19058 - October 27)

FLAGSHIP TAX EXEMPT FUNDS TRUST, ET AL.

A conditional order has been issued on an application filed by Flagship Tax Exempt Fund Trust, et al. under Section 6(c) of the Investment Company Act granting an exemption from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The exemption permits applicants to issue four classes of shares representing interests in the same portfolio of securities and assess and under certain circumstances, waive a contingent deferred sales load on certain redemptions of shares of two of the classes. (Rel. IC-19059 - October 27)

THE MASTERS GROUP OF MUTUAL FUNDS, ET AL.

An order has been issued on an application filed by The Masters Group of Mutual Funds, et al. under Section 6(c) of the Investment Company Act granting an exemption from the provisions of Sections 18(f)(1), 18(g) and 18(i) of the Act. The exemptions apply to the extent necessary to permit certain open-end management investment companies to issue and sell separate classes of shares representing interests in the same investment portfolio. (Rel. IC-19060 - October 27)

HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM

A notice has been issued giving interested persons until November 16, 1992 to request a hearing on a proposal by New England Electric System (NEES), a registered holding company, to extend until December 31, 1996 the time in which it may issue and sell up to an aggregate of 81,409 shares of its common stock to the NEES Companies Employees' Share Ownership Plan. NEW ENGLAND ELECTRIC SYSTEM

A notice has been issued giving interested persons until November 16, 1992 to request a hearing on a proposal by New England Electric System (NEES), a registered holding company, to extend until December 31, 1996 the time in which it may issue and sell up to an aggregate of 2,192,122 shares of its common stock to the NEES Companies Incentive Thrift Plan. NORTHEAST UTILITIES, ET AL.

A notice has been issued giving interested persons until November 16, 1992 to request a hearing on a proposal by Northeast Utilities (Northeast), a registered holding company, and its subsidiary companies (Subsidiaries), Holyoke Water Power Company (Holyoke), Western Massachusetts Electric Company (WMECO), Quinnehtuk Company (Quinnehtuk), Public Service Company of New Hampshire (PSNH), North Atlantic Energy

Corporation (North Atlantic), The Connecticut Light & Power Company (CL&P), Northeast Nuclear Energy Company (Nuclear) and The Rocky River Realty Company (Rocky River), (all companies collectively, Applicants).
